CUMBERLAND COUNTY UTILITIES AUTHORITY December 15, 2016

The Cumberland County Utilities Authority (CCUA) held its Regular Monthly Meeting on Thursday December 15, 2016, in the Meeting Room of the Operations Building, 333 Water Street, Bridgeton, New Jersey.

Chairman Jones called the meeting to order, announced that adequate notice of this meeting has been given in accordance with Chapter 231, P.L. (THE OPEN PUBLIC MEETING ACT) and led in the flag salute.

Secretary Hill called the roll and a quorum was present. .

Chairman Jones called for a motion to approve the minutes of the Regular Monthly Meeting and Executive meeting of November 21, 2016 Motion was made by Commissioner Rajacich, seconded by Vice-Chairman Wasserman and carried unanimously at roll call. Commissioner Edwards' vote was recorded as abstained.

REPORTS

Director

Director Errickson submitted the November 2016 Discharge Monitoring Report (DMR) for inclusion into the minutes of this meeting. The Director noted that the plant is operating well and we continue to meet our effluent discharge limits in the single digits. The Director also noted that we received a response to our stay request submitted late last year for our new discharge permit. The new permit included two tests for which we had no past history to determine whether we could meet the limits imposed. The request was denied on the basis that we did not provide any past history and in the absence of past history at least one test result. It seems absurd to base a permit limit on one test result. Fortunately, for the year to date we have not had an issue meeting the new limits so it is not an issue. However, we could have been exposed to substantial penalties if we had violations during this time.

He further reported that we continue to hold weekly meetings with CME and Center Point Construction in order to keep track of progress and insure good communications. The primary work is taking place at the Clarifier and has been more difficult than anticipated. Almost all the coating has been removed but the weather has turned against us for the new coating. Because of that the contractor is going to suspend further work until January 20, 2017. We believe weather conditions are essential for the coating to be applied properly and therefore granted the contractors request.

Director Errickson noted that Cumberland County Government has mandated all of its employees receive direct deposit of their pay. We here at the Authority have received correspondence from the DCA (Department of Community Affairs) indicating they have the ability to mandate direct deposit for all employees and that it can be used as an additional tool to control personnel cost. Given that, meetings have been held with plant employee representatives and employees who agree that direct deposit is a good thing and so far everyone is in favor.

Director Errickson also reported that we have called on C&H to assist with hauling excess sludge inventory that has built up over the last six months. With our current sludge management operations any day we cannot remove sludge for any reason means we will be accumulating sludge in storage. This will ultimately need to be removed using overtime or contract hauling.

The Director reported that new NJ Infrastructure Trust loan policies require us to have some kind of equipment and maintenance management software in place. We have a system that was developed by our staff that seems to meet the overall goals of this policy. We will be reviewing it with the engineer to see what improvements may need to be made to comply with this policy.

The Director also informed the Authority Board that a notice of violation has been issued to Cumberland Dairy for permit violations in September and October of this year. These occurred at the time that Cumberland Dairy was to have completed water re-use measures intended to reduce the peak discharge and capture high-strength wastes. The notice of violation includes an order to proceed with plans for design and construction of an expanded pretreatment plant.

The Director reported that there are a large number of resolutions tonight and will not go into detail about each one. Hopefully everyone has read and understands them and will be ready to vote on these matters. There is resolution "R" that needs some clarification before you vote. Resolution "R", deals with the offer of full time employment to Daniel Jefferson. Mr. Jefferson has completed his ninety day probationary period and has agreed to sign a three year contract in January 2017. Labor counsel will provide this contract to the Authority.

There is need to have a closed session tonight to discuss Personnel issues with action to be taken when back in public session.

The Director also reminded everyone that John Healy is conducting his annual Christmas Bike Drive for kids again this year and all donations will be greatly appreciated.

Director Errisckson extended his wishes to everyone for a Merry Christmas, Happy Chanukah and a Wonderful Kwanza.

In conclusion, the Director offered his thanks to Deputy Director Michael Fernandez, Administrative Assistant Stephanie Mick, Business Administrator Dominic Buirch, Authority Engineer Jerry Harris and General Counsel James Grace for their help with preparing his report. The Director also offered his thanks to everyone for their hard work and support given to him this past year. A Special thank you was offered to Deputy Director Frenandez who will be retiring the end of this month.

Engineer

Upper Deerfield Pump Station, Lance Electric, Inc. of Tabernacle NJ was given a notice to Proceed on October 13, 2016. The contactor has been submitting shop drawings which are being reviewed by CME. Construction activities anticipated to start shortly.

Wastewater Treatment Plant Improvements, Centerpoint Associates, Blackwood NJ was also given a Notice to Proceed and has been submitting shop drawings which are being reviewed by CME. Construction activities started the week of October 17, 2016. The initial work is on the Primary Clarifier. The estimated construction period for each job is approximately one year.

The 2016 Annual Report was finalized and submitted to the Authority for forwarding to the Bond Trustee.

Mr. Harris reported that he has continued assisting staff in planning solids handling improvements for the Plant with an emphasis on screening improvements as a first phase.

There was no activity on the Plant Discharge Permit. We are waiting for NJDEP response to request for Adjudicatory Hearing / Permit Stay.

Mr. Harris lastly reported that he was available to provide assistance to the Director and Deputy Director on engineering matters, and coordinated with Bond Counsel on NJEIT loan.

Auditor

Mr. Testa reported that he provided staff assistance and worked with management and Bond Counsel with respect to the recently closed Series 2016 NJEIT Interim Loans.

Mr. Testa also noted Resolution A on the agenda, which is the Resolution to Adopt the 2017 Budget. The State has given approval to adopt the 2017 Budget and the Authority held its public hearing on the Budget at the November meeting, and it is appropriate to adopt the budget at this time.

Resolution B is an annual resolution which directs the trustee to transfer the interest earned in the Renewal & Replacement Fund to the Revenue fund as required by the Authority Bond Resolution.

There are other reorganization type resolutions such as Resolution C, D and E that are done each year regarding official banks and depositories and banking business as well as updating the Authority's Cash Management Plan as required. These generally authorize the Authority to do business with certain banks and establish accounts, however this can be amended during the year should the Authority wish to do so.

Lastly, and not to be presumptuous, noted is a resolution on the agenda reappointing our firm for 2017. I truly appreciate the Authority's continued confidence in our firm and, as always look forward to serving the Authority.

General Counsel

Mr. Grace reported at this time he had no new information to report with respect to Biosolids. He will continue to explore options that will place our Authority in a position where we can save money and continue to help the environment as well as farmers in the surrounding area.

Mr. Grace noted that we have accomplished a significant amount of goals throughout the last calendar year, whether it be the resolution of three litigation matters, as well as significant progress in our solar project.

Mr. Grace reported the submission of documents previously prepared was sent to the New Jersey Department of Environmental Protection for review and determination of fitness of our surrounding lands

for our proposed 1.5 megawatt solar project. Again we anticipate a positive response from the NJDEP. Furthermore, we have also sent an RFP with respect to the preparation of the bid documents and the power purchase agreement for said project. This will only be contingent upon said project being approved by the NJ DEP.

Mr. Grace stated he was available for any questions or concerns by the Director, staff and Commissioners.

Committees

There were two committee meetings this past month. The Employee Relations and Finance and Budget Committees both met on Monday December 12, 2016. Copies of the minutes from both meetings are included in the Commissioner's folders today.

A RESOLUTION ADOPTING THE 2017 BUDGET CUMBERLAND COUNTY UTILITIES AUTHORITY FISCAL YEAR PERIOD JANUARY 1, 2017 TO DECEMBER 31, 2017

WHEREAS, the Annual Budget and Capital Budget for the Cumberland County Utilities Authority for the fiscal year period beginning January 1, 2017 and ending December 31, 2017 has been presented and adopted before the Commissioners of the Authority at its open public meeting of December 15, 2016; and

WHEREAS, the Annual Budget and Capital Budget as presented for adoption reflects each item of revenue and appropriation in the same amount and title as set forth in the introduced and approved budget, including all amendments thereto, if any, which have been approved by the Director of the Division of Local Government Services; and

WHEREAS, the Annual Budget as presented for adoption reflects Total Revenues of \$6,889,880.00, Total Appropriations, including any Accumulated Deficit, if any, of \$7,014,880.00 and Total Unrestricted Net Position utilized of \$125,000.00; and

WHEREAS, the Capital Budget as presented for adoption reflects Total Capital Appropriations of \$457,000.00, Total Unrestricted Net Position planned to be utilized of \$150,000.00, and Total Renewal & Replacement Reserve Fund planned to be utilized of \$307,000.00.

Cumberland County Utilities Authority Cash Management Plan

I. STATEMENT OF PURPOSE

This Cash Management Plan (the "Plan") is prepared pursuant and subject to the provision of N.J.S.A. 40A: 5-14, et seq., as amended, in order to set forth the basis for the deposits ("Deposits") and investment ("Permitted Investments") of certain public funds of the Cumberland County Utilities Authority, pending the use of such funds for the intended purposes. The plan is intended to assure that all public funds identified herein are deposited in interest bearing Deposits or otherwise invested in Permitted Investments hereinafter referred to. The intent of the Plan is to provide that the decisions made with regard to the Deposits and Permitted Investments will be done to ensure the safety, liquidity (regarding its availability for the intended purposes), and the maximum investment return within such limits. The Plan is intended to ensure that any Deposit or Permitted Investment matures within the time period that approximates the prospective need for the funds deposited or invested so that there is not a risk to the market value of such Deposits or Permitted Investments.

II. IDENTIFICATION OF FUNDS AND ACCOUNTS TO BE COVERED BY THE PLAN.

A. The Plan is intended to cover the deposit and/or investment of all funds and accounts of the Cumberland County Utilities Authority to include:

The custodian of the accounts shall be the Chief Financial Officer. All disbursements shall be made by checks signed by three persons ("Officers") authorized by Resolution of the Authority with the exception of Other Trust Funds/Trust Accounts, which require the signature of the Chief Financial Officer only, or any three other Officers.

The Director/ Deputy Director of the Authority, is hereby designated as the Chief Financial Officer for the purposes of this Plan.

III. DESIGNATION OF OFFICIALS OF THE CUMBERLAND COUNTY UTILITIES AUTHORITY AUTHORIZED TO MAKE DEPOSITS OR INVESTMENTS UNDER THE PLAN.

The Chief Financial Officer (the "Designated Official") is hereby authorized and directed to deposit and/or invest the funds referred to in the Plan. Prior to making any such Deposits or any Permitted Investments, such official of the Cumberland County Utilities Authority is directed to supply all depositories or any other parties with whom the Deposits or Permitted Investments are made a written copy of this Plan which shall be acknowledged in writing by such parties and a copy of such acknowledgment kept on file.

IV. DESIGNATION OF DEPOSITORIES.

The following banks and financial institutions are hereby designated as official depositories for the Deposit of all public funds referred to in the Plan, including any certificates of deposit which are not otherwise invested in Permitted Investments as provided for in this Plan:

BB&T TD Wealth Management

In addition, the Authority by Resolution may designate such other and/or additional financial institution as official depositories provided that any New Jersey bank must be covered by the New Jersey Governmental Unit Deposit Protection Act (GUDPA).

All such depositories shall acknowledge in writing receipt of this plan by sending a copy of such acknowledgment to the Designated Official (s) referred to in Section III above.

V. DESIGNATION OF BROKERAGE FIRMS AND DEALERS WITH WHOM THE DESIGNATED OFFICIALS MAY DEAL.

The following brokerage firms and/or dealers and other institutions are hereby designated as firms with whom the Designated Official(s) of the Cumberland County Utilities Authority referred to in this Plan may deal for purposes of buying and selling securities identified in this plan as Permitted Investments or otherwise providing for Deposit, to wit, any member of the New York Stock Exchange (NYSE), American Stock Exchange (ASE), National Association of Securities Dealers (NASD), provided all transactions are executed in the delivery vs. payment form between the brokerage firm or dealer and Cumberland County Utilities Authority's designated custodian. All such brokerage firms and/or dealers shall acknowledge in writing receipt of this Plan by sending a copy of such acknowledgement to the Designated Official(s) referred to in Section III above.

VI. PERMISSIBLE INVESTMENTS.

- A. Investments shall be limited by the express authority of the Local Fiscal Affairs Law, N.J.S.A. 40A:5:15.1 and except as otherwise specifically provided for herein, the Designated Official is hereby authorized to invest the public funds covered by this Plan to the extent not otherwise held in Deposits, in the following Permitted Investments:
 - 1. Bonds or other obligations of the United States of America or obligations guaranteed by the United States of America and/or bonds or other obligations of the State of New Jersey or any of its political subdivisions provided that said bond or obligation is a legally authorized investment.
 - 2. Government money market mutual funds;
 - 3. Any obligation that a federal agency or a federal instrumentality has issued in accordance with an act of Congress, which security has a maturity date not greater than 397 days form the date of purchase provided that such obligation bears a fixed rate of interest not dependent on any index or other external factor;
 - 4. Bonds or other obligations of the Local Unit or bonds or other obligations of school districts of which the Local Unit is a part or within which the school district is located:
 - 5. Bonds or other obligations, having maturity date not more than 397 days from the date of purchase, approved by the Division of Investment of the Department of Treasury for investment by Local Units;
 - 6. Local government investment pools;
 - 7. Deposits with the State of New Jersey Cash Management Fund established pursuant to section 1 of P.L. 1977, c. 281 (C. 52:18A-90.4); or
 - 8. Agreements for the repurchase of fully collateralized securities if
 - a. the underlying securities are permitted investments pursuant to paragraphs (1) and (3) of this subsection;
 - b. the custody of collateral is transferred to a third party;
 - c. the maturity of the agreement is not more than 30 days;
 - d. the underlying securities are purchased through a public depository as defined in section 1 of P.L. 1970, c.236 (C.17:19-41); and
 - e. a master repurchase agreement providing for the custody and security of collateral is executed.

For purposes of the above language, the terms "government money market mutual fund" and "local government investment pool" shall have the following definitions:

Government Money Market Mutual Fund. An investment company or investment trust:

- which is registered with the Securities and Exchange Commission under the "Investment Company Act of 1940", 15 U.S.C. sec 80a-1 et seq., and operated in accordance with 17 C.F.R. sec 270.2a-7.
- (b) the portfolio of which is limited to U.S. Government securities that meet the definition of any eligible security pursuant to 17 C.F.R. sec. 270.2a-7 and repurchase

agreements that are collateralized by such U.S. Government securities; and which is rated by a nationally recognized statistical rating organization.

<u>L'ocal Government Investment Pool.</u> An investment pool:

(a) which is managed in accordance with 17 C.F.R. sec 270.2a7;

(b) which is rated in the highest category by a nationally recognized statistical rating organization;

which is limited to U.S. Government securities that meet the definition of an eligible security pursuant to 17 C.F.R. sec 270.2a-7 and repurchase agreements that are collaterized by such U.S. Government securities;

which is in compliance with rules adopted pursuant to the "Administrative Procedure Act", P.L. 1968, c 410 (c52: 14B-1 et seq.) by the Local Finance Board of the Division of Local Government Services in the Department of Community Affairs, which rules shall provide for the safety, liquidity and yield of the investments;

(e) which does not permit investments in instruments that: are subject to high price volatility with changing market conditions, cannot reasonably be expected at the time of interest rate adjustment, to have market value that approximates their par value; or utilized an index that does not support a stable net asset value; and

which purchases and redeems investments directly from the issuer, government money market mutual fund, or the State of New Jersey Cash Management Fund, or through the use of a national or State bank located within this State, or through a broker-dealer which, at the time of purchases or redemption, has been registered continuously for a period of at least two year pursuant to Section 9 of P.L. 1967 c.9 (C49:3-56) and has at least \$25 Million in capital stock (or equivalent capitalization if not a corporation), surplus reserves for contingencies and undivided profits or through a securities dealer who makes primary markets in U.S. Government securities and reports daily to the Federal Reserve Bank of New York its position in and borrowing on such U.S. Government Securities.

VII. SAFEKEEPING CUSTODY PAYMENT AND ACKNOWLEDGEMENT OF RECEIPT OF PLAN.

To the extent that any Deposit or Permitted Investment involves a document or security which is not physically held by the Cumberland County Utilities Authority, then such instrument or security shall be covered by a custodial agreement with an independent third party, which shall be a bank or financial institution in the State of New Jersey. Such institution shall provide for the designation of such investments in the name of the Cumberland County Utilities Authority to assure that there is not unauthorized use of the funds or the Permitted Investments of Deposits. Purchase of any Permitted Investments that involve Securities shall be executed by a "delivery versus payment" method to ensure that such Permitted Investments are either received by the Cumberland County Utilities Authority or by a third party custodian prior to or upon the release of the Cumberland County Utilities Authority funds.

To assure that all parties with whom the Cumberland County Utilities Authority deals either by way of Deposits or Permitted Investments are aware of the authority and the limits sets forth in this Plan, all such parties shall be supplied with a copy of this Plan in writing and all such parties shall acknowledge the receipt of that Plan in writing, a copy of which shall be on file with the Designated Official(s).

VIII. REPORTING REQUIREMENTS

At least monthly at a public meeting of the Authority, the Designated Official(s) referred to in Section III hereof shall supply to the Commissioners of the Cumberland County Utilities Authority a report of any Deposits of Permitted Investments made pursuant to this Plan, which shall include, at a minimum, the following information:

- A. The name of any institution holding funds of the Cumberland County Utilities Authority as a Deposit or a Permitted Investment.
- B. The amount of securities or Deposits purchased or sold during the immediately preceding month.
- C. The class or type of securities purchased or Deposits made.
- D. The book value of such Deposits or Permitted Investment.
- E. The earned income on such Deposits or Permitted Investments.
- F. The fees incurred to undertake such Deposits or Permitted Investments.
- G. The market value of all Deposits or Permitted Investments as of the end of the immediately preceding month.
- H. All other information which may be deemed reasonable from time to time by the Commissioners of the Cumberland County Utilities Authority.

The report shall include all monthly trustee and other bank statements containing the required information.

IX. TERM OF PLAN

This Plan shall be in effect from January, 2017 to December, 2017. Attached to this Plan is resolution adopted by the Commissioners of the Cumberland County Utilities Authority approving this Plan for such a period of time. The Plan may be amended from time to time. To the extent that any amendment is adopted by the Commissioners of the Cumberland County Utilities Authority, the Designated Official is directed to supply copies of the amendments to all of the parties who otherwise have received the copy of the originally approved Plan, which amendment shall be acknowledged in writing in the same manner as the original Plan was so acknowledged.
