# CUMBERLAND COUNTY UTILITIES AUTHORITY August 17, 2017

The Cumberland County Utilities Authority (CCUA) held its Regular Monthly Meeting on Thursday August 17, 2017, in the Meeting Room of the Operations Building, 333 Water Street, Bridgeton, New Jersey.

Chairman Jones called the meeting to order, announced that adequate notice of this meeting has been given in accordance with Chapter 231, P.L. (THE OPEN PUBLIC MEETING ACT) and led in the flag salute.

Secretary Hill called the roll and a quorum was present.

Chairman Jones called for a motion to approve the minutes of the Regular Monthly Meeting and the Executive Session minutes of July20, 2017. Motion was made by Commissioner VanSant seconded by Commissioner Rajacich and carried unanimously at roll call. Commissioner Edward's vote was recorded as abstained.

#### REPORTS

#### Director

Director Errickson submitted the July 2017 Discharge Monitoring Report (DMR) for inclusion into the minutes of this meeting. The Director noted that the plant is operating well and we continue to meet our effluent discharge limits in the single digits.

Director Errickson reported that the A.E.A. Directors meeting was held this month at GCMUA. Some of the topics discussed were Budget and Finance, Renewal and Replacement, General Fund, Reconstruction and Replacement Fund. What came to light was how close some authorities are to being underfunded and would be unable to handle a severe emergency. This is not the case with the CCUA.

Director Errickson reported meeting with Labor Counsel to discuss upcoming talks regarding Employee Handbook. Current work agreement with plant employees runs out December 31, 2017.

The Director informed the Board that with our current sludge management operations we have been able to maintain the appropriate sludge inventory. We are currently disposing of two trailer loads per day at DELCORA with all hauling being done internally. Sludge cake is being generated on a limited basis as we continue the process of optimizing the sludge screw press performance.

Director Errickson noted that a technician from Huber Technologies visited the plant late last month to evaluate the operation of both Q 440 screw presses currently in operation. After two days of testing and adjustments the presses are now considered to be running at maximum efficiency. It was suggested by the Huber technician that it may be advantageous to explore using liquid polymer to increase the solids concentration. The authority is currently investigating that option. SNF Polydyne, Inc. will be onsite Thursday August 17, 2017 (Today) to experiment with using liquid polymer for dewatering operations.

The Director also reported that GMH Associates of America, Inc. has been contracted to rebuild the drive unit in the north secondary clarifier. While reinstalling the drive unit it was discovered that the rake arm and drive unit support structure needed repairs. Emergency repairs are about to start.

The Director noted that progress is continuing at the Seabrook Pump Station. Lance Electric has recently contracted out excavation work to George Helmer Excavating.

The Director reported that there are three resolutions tonight. Resolution "A" payment for our two construction projects. Resolution "B" line item changes to the 2017 Budget. Resolution "C" approving emergency Change Order to the North Secondary Clarifier.

Director Errickson noted that the Finance and Budget Committee met to discuss line item changes. Changes were recommended by the Committee.

The Director also noted that the Facilities Expansion Committee met to discuss the ongoing construction projects. Due to possible litigation this will need to be discussed in the closed session.

In conclusion, the Director offered his thanks to Deputy Director Daniel Jefferson, Administrative Assistant Stephanie Mick, Business Administrator Dominic Buirch and. Authority Engineer Jerry Harris for their help with preparing his report.

#### Engineer

Upper Deerfield Pump Station- Lance Electric, Inc. of Tabernacle NJ - The existing generator building has been demolished and a new pre-fab building and a new generator have been set in place. The new valve chamber is also in place. Work is now focused on demolition of the existing dry well and installation of piping and manholes. Various major pieces of equipment have been delivered. Project is approximately 55% complete. Completion date is early November 2017.

Wastewater Treatment Plant Improvements- Centerpoint Associates, Blackwood NJ - Concrete repair/coating and metal painting activities have continued at the North Primary Clarifier. Work continued at the Headworks facility with regard to the installation of new handrails. The two new aeration blowers have been set in place in the Blower Building. Contract is approximately 80% complete. Completion date for contract is late September 2017.

Mr. Harris reported that he has continued assisting staff in planning solids handling improvements for the Plant with an emphasis on screening improvements as a first phase. He also noted that initial information gathering was completed for the Asset Management Plan. Preparation of the Asset Inventory task is in progress.

Mr. Harris lastly reported that he was available to provide assistance to the Director and Deputy Director on engineering matters, and coordinated with Bond Counsel on NJEIT loan.

#### Auditor

Mr. Testa reported that he has just completed and sent to the Authority the updated calculation of the Authority's maximum allowable Connection Fee as of December 31, 2016 in accordance with the Statutes. (N.J.S.A. 40:14B-22). The maximum allowable connection fee as of December 31, 2016 is \$ 3,405.00. The current fee charged by the Authority is \$ 2,960.00. This doesn't mean we have to charge the higher amount; however, the Authority is required to calculate the fee each year to determine the maximum amount that can be charged.

Mr. Testa also reported he has reviewed with management the Schedule of 2017 Budget Adjustments as well as the related information to be provided to the Division of Local Government Services pertaining to the budget Adjustments. He also reported attending a Finance and Budget Committee meeting regarding the same.

### **General Counsel**

Mr. Grace reported we are continuing the process of gathering the necessary data for purposes of submission of the CAFRA IP permit. He will continue to update as new information becomes available.

Mr. Grace announced that he has sent the appropriate notices to NJDEP, the NJ Attorney General's Office, the City of Bridgeton and Upper Deerfield Township along with the rate payer who is the subject of the issue. Cumberland Dairy has hired an attorney and he has been in discussions about the substantive issues related to the case. We are currently in the process of working it through. No resolution has been reached at this point. Updates will be provided as new information becomes available.

Mr. Grace then reported that a significant meeting with Lance Electric along with a phone conference with their bonding company. We were assured that the appropriate work will be completed as expeditiously as the circumstances and dates related to completion of the project. Again updates will be made as new information becomes available.

Lastly Mr. Grace reported that Director Erickson has resolved the matter and obtained payment in full from Upper Deerfield. The matter is now closed.

Mr. Grace stated he was available for any questions or concerns by the Director, staff and Commissioners.

#### **Committees**

There was a meeting of the Facility Expansion Committee on July 31, 2017 and the Finance and Budget Committee on August 14, 2017. The minutes from both meetings are included in the Commissioners packets today.

Upon discovery of items needing attention during the installation of the drive unit for Cumberland County Utilities Authority (Clarifier Drive Replacement) the following was noted:

On completion of the demolition phase of the retrofit and installation of the new drive we found several areas of severe deficiency. Specifically, the main clarifier support column and torque cage which is what is most concerning.

As noted in the pictures that are displayed, we found the support column severely corroded and found that some pieces actually had fallen into the inside of the center column.

What we suggest is that we, G.M.H. Associates of America, Inc will do a Mechanical Cleaning and Overlay with 304 SS Plate (Clad overlay with 304 SS Flat Bar).





The Torque Cage and Adaptor Pads are in need of scraping, re-welding in some areas, sandblasting and coating with Coal Tar Epoxy
