CUMBERLAND COUNTY UTILITIES AUTHORITY October 19, 2017

The Cumberland County Utilities Authority (CCUA) held its Regular Monthly Meeting on Thursday October 19, 2017, in the Meeting Room of the Operations Building, 333 Water Street, Bridgeton, New Jersey.

Representing the CCUA: Albert Jones, Chairman Angelia Edwards, Commissioner Harvey Friedman, Commissioner Zarko Rajacich, Commissioner Doug VanSant, Commissioner Jerry Young, Commissioner Steve Testa, Auditor James Grace, General Counsel Jerome Harris, Engineer C. Kenneth Hill, Secretary Ed Bethea, Treasurer G. Steven Errickson, Director Daniel Jefferson, Deputy Director Dominic Buirch, Business Administrator Stephanie Mick, Administrative Assistant

Chairman Jones called the meeting to order, announced that adequate notice of this meeting has been given in accordance with Chapter 231, P.L. (THE OPEN PUBLIC MEETING ACT) and led in the flag salute.

Secretary Hill called the roll and a quorum was present. Vice-Chairman Wasserman and Commissioner Young were recorded as excused absences.

Chairman Jones called for a motion to approve the minutes of the Regular Monthly Meeting and the Executive Session minutes of September 21, 2017. Motion was made by Commissioner Friedman, seconded by Commissioner Rajacich and carried unanimously at roll call.

REPORTS

Director

Director Errickson submitted the September 2017 Discharge Monitoring Report (DMR) for inclusion into the minutes of this meeting. The Director noted that the plant is operating well and we continue to meet our effluent discharge limits in the single digits.

Director Errickson reported meeting with the County Insurance Committee this month, some of the topics discussed were accidents and injuries and improvements that will make the work place safe and secure.

The Director also reported working with our Engineers from CME helping to monitor both Contractors and their projects, along with staying in communication with one of the Bond Companies who is also monitoring the work of the contractor.

The Director noted that the investigation into the high solids concentration located within Upper Deerfield Township influent has found the likely source. An inspection of the drinking water plants has found that the backwash is contributing abnormally high levels of solids. Upper Deerfield Township has been made aware of the findings and the CCUA considers the matter resolved.

Director Errickson noted that with our current sludge management operations we have been able to maintain the appropriate sludge inventory. We are currently disposing of two tractor trailer loads per day at DELCORA with all hauling being done internally. Sludge cake is being generated on a limited basis.

Then NJDEP preformed an inspection on October 6, 2017 with Operations and Maintenance, there were no deficiencies observed and the inspection went well.

The Director reported that there was training sessions for fall protection and electrical safety on October 5, 2017 with operations and maintenance personnel attending.

The Director reported that there are eight resolutions tonight. Resolution "A" payment for our two construction projects. Resolution "B" authorizing public notice for solicitation of Professional Services for 2018. Resolution "C" authorizing Public Hearing on amendments to the sewer use rules and regulations. Resolution "D" Authorizing the introduction of the 2018 Budget. Resolution "E" authorizing advertisement for bid of "Outside Laboratory Services". Resolution "F" awarding the contract for sandblasting and recoating superstructure and rake arm for the North Secondary Clarifier. Resolution "G" authorizing a Permit Modification on ownership of Cumberland Dairy to Rosenhayn Acquisitions. Resolution "H" authorizing advertisement for bids on supply and delivery of Sodium Bisulfate Solution.

Director Errickson reported that the Budget and Finance Committee met and reviewed the proposed New 2018 Budget and it was met with positive recommendation to the full Board.

In conclusion, the Director offered his thanks to Deputy Director Daniel Jefferson, Administrative Assistant Stephanie Mick, Business Administrator Dominic Buirch and. Authority Engineer Jerry Harris for their help with preparing his report.

Engineer

Upper Deerfield Pump Station- Lance Electric, Inc. of Tabernacle NJ. The Project is approximately 70% complete. Recent work included rehabilitation of the existing wet well, pipe installation, and valve chamber interior work. Various major pieces of equipment have been delivered. Completion date for contract is early November 2017. It is questionable whether it will be done on time.

Wastewater Treatment Plant Improvements- Centerpoint Associates, Blackwood NJ. The project is approximately 85% complete. The remaining major piece of the work is the final painting of the metalwork and the epoxy coating. The scheduled completion date has passed but hopefully in the next couple of weeks the contractor will finish.

Mr. Harris reported that he has continued to work on the annual report for the Bond Trustee. On October 12, the Deputy Director, Mr. Harris and some operations staff visited the pump stations and the treatment plant and he expects to have a draft report to the Director sometime next week.

He also noted that he continued working on the Asset Management Plan and that he plans to have a draft report sometime early next month.

Mr. Harris lastly reported that he was available to provide assistance to the Director and Deputy Director on engineering matters, and coordinated with Bond Counsel on NJEIT loan.

Auditor

Mr. Testa reported that he worked with management and met with the finance and budget committee with regards to the proposed 2018 Budget. He stated that there is a resolution scheduled for tonight for introduction of the 2018 Budget.

Mr. Testa also reported that once the budget is introduced, it will be submitted to the State of New Jersey Division of Local Government Services for their review. The State will then have 45 days to perform their review. As required by the Authority's Bond Resolution, the Authority will hold its public hearing on the proposed budget at the November meeting. Once the Authority receives State approval, it can adopt the budget at the December meeting, as required.

General Counsel

Mr. Grace reported on the proposed Solar Project that we were in the process of finalizing all the necessary information to be contained in the competitive bid. He hopes that the project can be out to bid in the next 45 days or so.

Mr. Grace announced that regarding Cumberland Dairy the matter is fully settled. He is fully satisfied with the settlement and the matter is fully closed at this time.

Mr. Grace then reported no new information relative to the matter with Atlantic Electric is available at this time.

Mr. Grace stated he was available for any questions or concerns by the Director, staff and Commissioners.

Committees

There was a meeting of the Finance and Budget Committee on September 19, 2017. Commissioner VanSant reported that the committee reviewed the proposed 2018 Budget and they recommend it to the board.

WHEREAS, the Capital Budget as introduced reflects Total Appropriations of \$873,884.00 Total Unrestricted Net Position planned to be utilized as funding thereof of \$150,000.00 and Renewal & Replacement Reserve is planned to be utilized as funding thereof, of \$723,884.00; and

WHEREAS, the schedule of rates, fees and other charges in effect will produce sufficient revenues, together with all other anticipated revenues to satisfy all obligations to the holders of bonds of the Authority, to meet operating expenses, capital outlays, debt service requirements, and to provide for such reserves, all as may be required by law, regulation or terms of contracts and agreements; and

WHEREAS, the Capital Budget/Program, pursuant to <u>N.J.A.C.</u> 5:31-2, does not confer any authorization to raise or expend funds, rather it is a document to be used as part of the said Authority's planning and management objectives. Specific authorization to expend funds for the purposes described in this section of the budget, must be granted elsewhere, by bond resolution, by a project financing agreement, by resolution appropriating funds from the Renewal and Replacement Reserve or other means provided by law.

NOW, THEREFORE, BE IT RESOLVED by the Commissioners of the Cumberland County Utilities Authority as follows:

 At a open public meeting held on October 19, 2017, that the Annual Budget, including all related schedules, and the Capital Budget of the Cumberland County Utilities Authority for the fiscal year beginning January 1, 2018 and ending December 31, 2018 is hereby recommended for approval; and

2. That a Public Hearing on the 2018 Budget be scheduled at the November 20, 2017 open public meeting of the Authority, notice of which will be published in the South Jersey Times (formerly Bridgeton Evening News) at least twenty (20) days prior to the date of the Public Hearing, after which it will be scheduled for adoption.

BE IT FURTHER RESOLVED, that the anticipated revenues as reflected in the Annual Budget and Capital Budget are of sufficient amount to meet all proposed expenditures/expenses and all covenants, terms and provisions as stipulated in the said Authority's outstanding debt obligations, capital lease arrangements, service contracts, and other pledged agreements; and

BE IT FURTHER RESOLVED, that the members of the Cumberland County Utilities Authority will consider the Annual Budget and Capital Budget for adoption on December 21, 2017.
