REGULAR MEETING CUMBERLAND COUNTY UTILITIES AUTHORITY December 20, 2012

The Cumberland County Utilities Authority (CCUA) held its Regular Monthly Meeting on Monday, December 20, 2012 in the Meeting Room of the Operations Building, 333 Water Street, Bridgeton, New Jersey.

Representing the CCUA: Nancy Sungenis, Chairperson Albert Jones, Vice Chairman James Begley, Commissioner Sam Boutros, Commissioner James Crilley, Commissioner Angelia Edwards, Commissioner Harvey Friedman, Commissioner Donald Olbrich, Commissioner Keith Wasserman, Commissioner Ronald Curcio, Engineer Steve Testa, Auditor James Quinn, Treasurer Robert O'Donnell, General Counsel Patti McAllister, Assistant Secretary Theodore Propert, Director Sandy Acevedo, Business Administrator A Michael Fernandez, Deputy Director

Chairperson Sungenis called the meeting to order, announced that adequate notice of this meeting has been given in accordance with Chapter 231, P. L. 1975 (THE OPEN PUBLIC MEETING ACT) and led in the flag salute.

Assistant Secretary McAllister called the roll and a quorum was present.

Chairperson Sungenis called for a motion to open the meeting to the public for the purpose of presenting questions or comments relative to the issuance of Bonds for the purpose of financing the cost of construction upgrades. Motion was made by Commissioner Olbrich, seconded by Commissioner Jones, and carried unanimously at roll call.

With there being no comments, Chairperson Sungenis called for a motion to close the public hearing. Motion was offered by Commissioner Jones, seconded by Commissioner Olbrich and carried unanimously at roll call.

Chairperson Sungenis asked for a motion to return to the Regular Meeting. Motion was made by Commissioner Olbrich and seconded by Commissioner Edwards, carried unanimously at roll call.

Chairperson Sungenis called for a motion to approve the minutes of the Regular Monthly Meeting of November 19, 2012. It was motioned by Commissioner Wasserman, seconded by Commissioner Boutros and was carried unanimously at roll call. Commissioner Crilley asked to clarify a statement made by Commissioner Boutros in the Minutes of November 19, 2012, but it is noted that it was not a revision to the minutes.

REPORTS

Director

Director Propert submitted the November Discharge Monitoring Report (DMR) for inclusion in the minutes of this meeting. The plant met all parameters for the month.

Director Propert noted that there were three resolutions removed from the agenda tonight. These were for the appointment of the public information officer, a shared service agreement with the Newfield Board of Education and the award of the construction bid for the FY 2013 Plant Upgrades.

He further reported that there was a bid opening for the 2013 Treatment Plant Upgrades, held this past Tuesday, December 18th. The bids are currently being reviewed by the engineer and legal counsel and their recommendation will be given to the Facilities Expansion Committee. A meeting will be scheduled after the holidays.

Final close-out of the 2010 NJEIT bond was received last week. It came in, well under budget, so it shortens the Authority's bond obligation by 6 years. The pay-off date is now in 2026, instead of 2032.

The 2013 budget received local board of finance approval this week, so that can be voted on tonight.

The Govdeals sale this year didn't result in as much revenue as in the past, but the Authority didn't have as much to sell. It netted \$470.00 for some scrap pumps, printers and a copier.

Director Propert stated that the majority of resolutions on the agenda tonight are for various appointments and authorizations for signatory requirements for banking and other regulatory agencies.

He stated that Resolution Q is a volume waste agreement with CCIA. Their contract expires the end of the month and we have re-negotiated their contract since they have put in a new treatment system and their quality of wastewater has improved greatly.

In conclusion, Director Propert announced that he would be retiring at the end of the month. He stated that it's been a very educational and rewarding 36 years at CCUA. Also that he has had the opportunity to work with and meet some very talented and interesting people, and he made some very dear friends. He further offered his thanks to the current and past CCUA commissioners for their support and trust. And he added a special thanks to his staff for all their hard work and support.

Engineer

Mr. Curcio wished Ted well on his retirement. He reported that bids were received and read aloud on Tuesday for the FY 2013 Treatment Plant Upgrades project. There were seven bidders and bids ranged from \$1.67 million to \$2.19 million with the four lowest bidders being within 7% of each other. Mr. Curcio along with General Counsel will review the bids and have an award recommendation at the Authority's next meeting in January. The apparent low bid is well below the requested and approved Environmental Trust funding for the project.

Auditor

Mr. Testa also wished Ted well. He reported that Resolution B adopts the 2013 Budget and that the State has given approval to adopt the 2013 Budget. The Authority held its public hearing on the 2013 Budget at the November meeting and it is appropriate to adopt the budget at this time.

Resolution C is an annual resolution which directs the trustee to transfer the interest earned in the Renewal & Replacement Fund to the Revenue fund as required by the Authority's Bond Resolution.

There are other reorganization type resolutions; "D", "E" and "F" that are done each year regarding official banks and depositories and banking business as well as updating the Authority's Cash Management Plan as required. These generally authorize the Authority to do business with certain banks and establish accounts; however, this can be amended during the year, should the Authority wish to do so.

Resolution P is a Supplemental Resolution Authorizing the Issuance of not to exceed \$2,100,000 Aggregate Principal Amount of Sewer System Revenue Bonds, Series 2013 of the Cumberland County Utilities Authority. This is in relation to the projects to be funded by the NJEIT bonds.

In conclusion, Mr. Testa stated that he noted the resolution on the agenda reappointing his firm for 2013. He expressed his appreciation of the Authority's continued confidence in their firm and, as always, looks forward to serving the Authority.

General Counsel

Mr. O'Donnell reported that he reviewed all the bids submitted this past month for the Auditor, Engineer and two other bids for work to be done for the Authority, to ensure that they were complaint.

He further stated that he attended the Budget and Finance Committee meeting as requested and provided legal assistance at the Workshop meeting on December 17, 2012. And as always, was available to answer questions and concerns from staff or commissioners.

Mr. O'Donnell noted Resolution L on the agenda which appoints him as General Counsel and assuming it's approved, expressed his appreciation for the board's confidence.

In closing, Mr. O'Donnell commended Ted on all the work he has done for the Authority. He stated that he has worked with more than one Director and in his opinion; Ted has done a fantastic job in putting the Authority in the right direction, with the new rates, the savings and the great work done.

Committees

The Finance and Budget Committee, chaired by Commissioner Wasserman met on December 6, 2012 to discuss and review the Professional RFQs. Minutes of the meeting are included in the packages of the Commissioners.

The Industrial Waste Committee, chaired by Commissioner Crilley met on December 6, 2012 to discuss Buona Vita violations and the CCIA agreement. Minutes of the meeting are included in the package. Committee Chairman Crilley added that anytime any of the industries users are involved with fines or violations, it' a tough decision to make and he felt Mike Fernandez did a super job in trying to prevent this.

Treasurer Quinn offered his good luck wishes to Ted on his retirement, stating that it has been nice working with him. He further reported that the bills submitted for payment today for the Operating Account total \$185,837.38. The Authority Chairperson and Assistant Secretary have checked the vouchers. The Operating Account has sufficient funds to cover these checks and approval of Resolution B is recommended.

For the first eleven months of 2012, revenues have exceeded expenses by \$711,634.61. The Treasurer stated that the monthly bank statements are available for review if anyone is interested.

Chairperson's Remarks

Chairperson Sungenis thanked Ted for doing more than an excellent job as Director. She expressed that he has always talked with her and the board on everything; he's done a fine job of saving money for the Authority and has always reached out to everyone. She also expressed her appreciation to the Deputy Director and staff for their hard work. She again thanked Ted and expressed her desire that in the future, everyone work together, show they care for each other and not always be so quick to find fault.

Commissioners

Each of the Commissioners on the Board, in turn, expressed their best wishes to Ted in his retirement with some good natured jest and remarks of his outstanding performance as Director of the Cumberland County Utilities Authority. Many also offered their condolences to Ron Curcio in the death of a family member.

Kenneth Hill was congratulated on his appointment and Chairperson congratulated the professionals on their appointments and thanked them for their continued excellent service.

Public

Eileen Clark clarified a comment she made at the last meeting in reference to the Committee members being employees, she meant Commissioners. She also thanked Chairperson Sungenis for her closing remarks in regards to the board working together, for the betterment of the public.

Deputy Director Fernandez said a few words congratulating Ted on his retirement and commending him on his work as Director. Mr. Fernandez stated that prior to Ted starting the position as Director, the Authority regularly had to use budget fund appropriations and the cash on hand was getting dangerously low, as per bond requirements. Ted totally reversed that trend and the Authority is on a much sounder financial ground. Also, Mr. Fernandez noted that Ted was the first to tackle the new billing system, which was long over-due. Although this coming year may be a little rough with getting the new billing implemented, in the long run, it should prove to be better for both the Users and the budget. Mike further stated that Ted also did a great job in restructuring our employee handbook. He put in a system that gives employees a goal to work towards, but establishes a longer time frame getting to top rate with a series of increases which reduces over-all personnel costs and promotes better employees. Mr. Fernandez thanked Director Propert for doing all this, before he left.

Chairperson Sungenis again thanked Deputy Director Fernandez for his part and doing a fine job.

Mr. Kenneth Hill expressed his appreciation for being appointed Secretary and is looking forward to working with the Authority members in 2013. He also wished Mr. Propert the best on his retirement.

The meeting was adjourned on a motion from Commissioner Olbrich.

SUPPLEMENTAL RESOLUTION AUTHORIZING THE ISSUANCE OF NOT TO EXCEED \$2,100,000 AGGREGATE PRINCIPAL AMOUNT OF SEWER SYSTEM REVENUE BONDS, SERIES 2013 OF THE CUMBERLAND COUNTY UTILITIES AUTHORITY

WHEREAS, The Cumberland County Utilities Authority was originally created as The Cumberland County Sewerage Authority pursuant to the county sewerage authorities law, which constituted Chapter 123 of the Pamphlet Laws of 1946 and the acts amendatory thereof or supplemental thereto, codified as N.J.S.A. 40:36A-1 et seq., which was repealed by P.L. 1977, c. 384, Section 16, effective February 10, 1978; and

WHEREAS, The Cumberland County Sewerage Authority was reorganized as The Cumberland County Utilities Authority and continues to exist and to operate pursuant to the municipal and county utilities authorities law, N.J.S.A. 40:14B-1 et seq. (P.L. 1957, Chapter 183, effective August 22, 1957, and the acts amendatory thereof and supplemental thereto) (the "Act") and pursuant to a resolution of the Board of Commissioners, which was duly filed with the Secretary of State of the State of New Jersey (The Cumberland County Sewerage Authority until its reorganization and The Cumberland County Utilities Authority after its reorganization being herein referred to as the "Authority"); and

WHEREAS, the Act provides that the Authority shall have the power to borrow money and issue its bonds and other obligations and to provide for the rights of the holders of its bonds and other obligations, as provided in the Act, for the purpose of financing the cost of any part of the sewer system (the "System") servicing certain residents of the County of Cumberland (the "County") and for the refunding of outstanding obligations of the Authority; and

WHEREAS, on February 7, 1977, the Authority adopted a general bond resolution entitled, "Resolution Providing for the Issuance of Bonds of The Cumberland County Sewerage Authority and for the Rights of the Holders Thereof, Determining to Construct the Phase I Project of the Authority, Estimating the Cost of the Phase I Project, and Authorizing Initial Bonds to Finance the Portion of Such Estimated Cost Not Paid or Provided for from Governmental Grants for the Phase I Project" (the "General Bond Resolution"); and

WHEREAS, the General Bond Resolution authorizes the Authority to provide for the construction or acquisition of Projects (as defined in the General Bond Resolution) other than the Initial Project (as defined in the General Bond Resolution) and to repay or refund any outstanding bonds and to issue one or more series of Additional Bonds (as defined in the General Bond Resolution) for such purposes; and

WHEREAS, the Authority has determined to issue sewer revenue bonds pursuant to and in accordance with the General Bond Resolution in the principal amount of not to exceed \$2,100,000 for the (a) replacement of floating steel covers on two digesters, the replacement of air distributers in the plant's aeration tank, the installation of a new sludge press for bio-
