REGULAR MEETING CUMBERLAND COUNTY UTILITIES AUTHORITY August 15, 2013

The Cumberland County Utilities Authority (CCUA) held its Regular Monthly Meeting on Thursday, August 15, 2013 in the Meeting Room of the Operations Building, 333 Water Street, Bridgeton, New Jersey.

Chairman Jones called the meeting to order, announced that adequate notice of this meeting has been given in accordance with Chapter 231, P.L. (THE OPEN PUBLIC MEETING ACT) and led in the flag salute.

Secretary Hill called the roll and a quorum was present. Commissioners Ed Bethea, Angelia Edwards and Vice Chairman Keith Wasserman were absent. Vice Chairman Wasserman is recorded as an excused absence.

Chairman Jones called for a motion to approve the minutes of the Regular Monthly Meeting of July 18, 2013. Motion was made by Commissioner Olbrich, seconded by Commissioner Friedman and was carried unanimously at roll Call.

Chairman Jones called for reports.

REPORTS

Director

Director Errickson submitted the July 2013 Discharge Monitoring Report (DMR) for inclusion in the minutes of this meeting.

The Director reported that on July 22, 2013, he and Deputy Director Fernandez along with Cumberland County Freeholder Anthony Surace and other county officials toured Gandy's Beach and Money Island with members of NJ DEP and a representative of the Governor's office. The tour was to review storm damage from hurricane Sandy in hopes to help determine a recovery plan. As reported last month, the CCUA was asked about possible installation of sewer lines connecting to the Bay Shore communities in Cumberland County.

He further reported that he and Deputy Director Fernandez also toured the Alloway MUA on July 23, 2013. Alloway has a sewer system in place that could well suit the needs of the Bay Shore and Cumberland County.

He informed the board that he attended a meeting on August 14, 2013 with Freeholders Surace and Long; mayors from all the Bay Shore towns, as well as many officials from Cumberland County and local government officials in attendance. He stated that he gave a very preliminary report on what it would take to

install sewer service from the Authority to the Bay Shore area. Early cost estimates are a minimum of thirty million dollars and a max of sixty million dollars. Those who attended the meeting were interested and wanted more information. Another meeting has been scheduled for August 22, 2013, at which time Director Errickson and others will present a more formal plan for installing sewer to the Bay Shore communities. It is projected that there will be eighty percent drawings presented, details of pump station locations and various options to choose from. Also a representative from a manufacturing company will be on hand to demonstrate equipment used in this type of system. It was noted that a Public Notice will be published by the County Freeholder Board, so that all can attend and not violate Sunshine Laws.

Director Errickson reported that two Plant Upgrade Projects meetings were held on July 23 and August 14, 2013 to discuss issues concerning the project, such as phasing, schedule cost and safety. The project is now 45 % complete and within budget.

Director Errickson also noted that he has been working with Dale Finch with coordination and sharing of services wherever possible, throughout the County.

On August 5, 2013, the New Jersey JIF inspector Anthony Fragale and Construction Code Inspector 2, Michael Braciszewski of the Bureau of Boilers and Pressure Vessels Compliance, came on site to look at our boilers. After conducting their inspection, both agreed to allow CCUA to proceed with our plan to resolve alleged water/fuel issues. The plan is to first have a certified boiler mechanic adjust the air/fuel mixture. The next step would be to fire up the boiler as soon as the Digester Project is completed and goes back on line, in October 2013. The boiler will be run until April 15, 2014, then shut down. After the boiler is shut down, both inspectors will return to re-inspect the boiler. It was also agreed to have both boilers Hydrostatic tested per their request, as this type of testing has not been done in some time.

He stated that a staff meeting was held on August 7, 2013 to discuss a number of items, including the Digester project, phasing and coordination within the plant, overtime and plant policies.

On August 9, 2013, he also met with the staff on the 2013 Budget Amendments. A committee meeting will be scheduled in the very near future for the Finance and Budget Committee to review and approve these line item changes. The members of this Committee are Commissioners Wasserman, Bethea and Olbrich. This process must be completed and voted on at the September Board Meeting.

Resolution "A" on the agenda authorizes the disposal of surplus property through GOVDEALS.

In continuing his report, Director Errickson stated that the Authority is currently land applying sludge at Cumberland Nursery and hauling sludge cakes to GCUA as needed.

Spectraserv has completed cleaning of the primary digester. However, due to the construction schedule and operational issues related to the infrastructure improvement contract, they will not be able to complete the secondary digester as planned and will need to return. While this will result in additional mobilization charges, the total cost should still be well below the estimated cost, due to the volume of material being less than projected. The total bid was for \$192,000, which included \$12,000 for mobilization / demobilization, the Primary digester cleaning was \$57,751.50 including \$12,000 for mobilization / demobilization. Assuming the secondary digester will not exceed the quantities of the primary, and incur a second mobilization / demobilization charge, the total cost for cleaning should come in around \$116,500.

Inspection of the digester interior, following the cleaning and removal of the cover, has revealed some areas where unanticipated work may be needed. The primary clarifier coating has been completed and looks good. The contractor has completed the removal of the old aeration panels from the south aeration basin, and is now working on installation of the sludge screw press and demolition of the primary digester cover.

Following removal of the digester cover, it was noted several of the sludge recirculation pipes had accumulated rags and debris; no work on these pipes was included in the construction contract. Our maintenance

staff is presently attempting to clear these pipes. However, given their relative inaccessibility, and the likelihood that similar conditions will be found in the secondary digester, we may need to appropriate additional funds for work on the interior pipes.

Lastly while Buona Vita had shown improvements in their pretreatment since hiring an operator, they are again having oil and grease discharge violations. The latest lab test showed oil and grease over 10,000 ppm; their limit is 150 ppm. We have had a substantial accumulation of grease in the head works and aeration basin, and fouling of dewatering equipment. We will be preparing a violation notice and penalty assessment to go out in September.

The Director also thanked the Deputy Director Michael Fernandez, Business Administrator Sandy Acevedo and Administrative Assistant Patti McAllister for their help with his reports this month.

Engineer

Mr. Harris reported he had attended a meeting on July 18, 2013 with the Director to discuss a Notice of Violation received from the Department of Labor (DOL) relative to the boilers at the Authority's digester facilities. Based on discussions at that meeting, CME prepared a letter to DOL dated July 25, 2013 outlining a plan to abate the alleged violations. We understand that the DOL has accepted the approach described in the letter and Staff will be proceeding with implementing it.

Mr. Harris also reported an inspection of the Authority's wastewater treatment plant and pump stations has been scheduled for August 13, 2013 in order to gather information to be used in updating the Authority's Five Year Capital Improvement Program.

Auditor

Mr. Testa was not required at this meeting and no report submitted.

General Counsel

Mr. O'Donnell stated that he had some conversations with the Director regarding the lawsuit over the clarifier and is waiting for cost estimates so he can prepare the Complaint.

Mr. O'Donnell stated he was available for any questions or concerns by staff and commissioners.

Committees

The Operations/Insurance committee met on Tuesday August 6, 2013. Committee Chairman Boutros stated that the purpose of the meeting was to discuss the renewal of our contract with the JIF Insurance Fund or to change. The Committee also asked for a proposal from the County JIF, will be considered. At this time no commitments have been made.
