#### REGULAR MEETING CUMBERLAND COUNTY UTILITIES AUTHORITY June 20, 2013

The Cumberland County Utilities Authority (CCUA) held its Regular Monthly Meeting on Thursday, June 20, 2013 in the Meeting Room of the Operations Building, 333 Water Street, Bridgeton, New Jersey.

Representing the CCUA: Albert Jones, Chairman Keith Wasserman, Vice Chairman Ed Bethea, Commissioner Sam Boutros, Commissioner Harvey Friedman, Commissioner Donald Olbrich, Commissioner Steve Testa, Auditor Jerome A. Harris, Engineer Robert O'Donnell, General Counsel James Quinn, Treasurer C. Kenneth Hill, Secretary G. Steven Errickson, Director A. Michael Fernandez, Deputy Director Sandy Acevedo, Business Administrator Patti McAllister, Assistant Secretary – Treasurer

Chairman Jones called the meeting to order, announced that adequate notice of this meeting has been given in accordance with Chapter 231, P.L. (THE OPEN PUBLIC MEETING ACT) and led in the flag salute.

Secretary Hill called the roll and a quorum was present. Commissioner Angelia Edwards is recorded as an excused absence.

Chairman Jones called for a motion to approve the minutes of the Regular Monthly Meeting of May 16, 2013 and the Special Meeting of June 4, 2013. Motion was made by Commissioner Bethea, seconded by Commissioner Olbrich and was carried unanimously at roll call.

Chairman Jones called for reports.

#### REPORTS

#### **Director**

Director Errickson submitted the May 2013 Discharge Monitoring Report (DMR) for inclusion in the minutes of this meeting. He stated that we were in compliance with all discharge permit limits but operationally, we continue to have difficulties with oil and grease and will begin some additional monitoring again.

The Director also noted that Ethics statements have been completed and submitted for the State of New Jersey.

Five employees of the CCUA have completed a two day instruction and training program in HAZMAT and will have that endorsement applied to their CDL. Another Safety Training program is scheduled for this month called "Train the Trainer". This is a program where select personnel will be trained in giving classroom instruction in specific safety regarding the CCUA plant. This safety program has been tailor made for the CCUA by our safety consultant using literature and power point presentation on CD to train plant employees and outside contractors before they start work on site. Cost of HAZMAT training was \$ 5,000 and Train the Trainer is \$3,100 for a total cost of \$ 8,100 which was paid for by Workforce Investment Board fund without cost to

CCUA or their employees. Also, since the last meeting Safety Training for Emergency Response, Fire Protection and extinguisher use was held.

He further reported that Quad Construction has arrived on site and started work on Monday June 17, 2013. Quad started work on the South Clarifier power washing and getting ready to paint. The contractor appears to be doing an excellent job in stripping all remnants of old coating off the concrete. Mr. O'Donnell will report on the issue with the North Clarifier crack and joint repair and its contractors J.P.Smith.

He noted that he along with Deputy Director Fernandez and Sandy Acevedo attended an A.E.A. seminar dealing with "Oversight of Construction Projects in your Plant". He felt that this was very worthwhile and they came away with some good ideas.

Director Errickson reported that the HVAC unit on top of the Administrative Building had to be replaced. The unit was very old and had outlived its usefulness. Prices obtained from outside contractors were approx. \$10,000, but in using plant personnel to do the replacement for \$3,000, the Authority had a savings of \$7,000.

Director Errickson reported that we still do not have an executed Shared Services Agreement. The CCIA is the lead agency and we are still working with them to bring together a signed contract. We cannot make payment until then.

Director Errickson also noted that we are presently in between field applications of sludge but expect to start back at Cumberland Nursery in the next couple of weeks. We plan on making contact with some additional nurserymen over the next few weeks to see if there is any interest in working with us for land application.

The Director also reported that after several requests over the past few years, South Jersey Ethanol has finally forwarded plans for their facility that is under construction in the Burlington Road Industrial park. They were provided with a connection fee amount for the office building that has been completed and permit requirements for the ethanol plant.

Industrial discharge permit renewal applications are being sent out to all currently permitted industries, as existing permits expire at the end of this year.

Also, a meeting has been scheduled with Upper Deerfield, on July 2, 2013, to review their sewer charges for Industrial users.

He further stated that we are working on our response to the NJDEP lab procedures inspection report.

In conclusion, Director Errickson briefly reviewed the resolutions on the agenda, stating Resolution A awards a contract for Cleaning the Digester; Resolution B establishes full time employment for N. Esposito, and Resolution C authorizes the sale of surplus property through Govdeals.

#### **Engineer**

Mr. Harris reported he had attended a meeting on May 21, 2013 with the Director, Deputy Director and General Counsel to discuss bids received for the Design and Purchase of Electrical Consumption Optimizing Equipment project, as well as the Digester Cleaning project. The problems that have been noticed with the previously installed tank coating were also discussed.

Mr. Harris went on to report that he had reviewed information from two bids submitted for the Design and Purchase of Electrical Consumption Optimizing Equipment. A letter was provided to the Director dated May 22, 2013 recommending that the Authority not award this bid to either bidder due to the uncertainties and lack of information in both bids. Because the electrical cost savings for the Authority could be a substantial

amount of money it was suggested that the Authority revisit the bid specifications for the project with the possibility of rebidding the project in the future.

Mr. Harris went on to report information from the three bids submitted for the current Digester Cleaning Project was reviewed. The apparent low bidder had an unbalanced bid. The bids were subsequently rejected and the project has been re-advertised for bid.

#### **Auditor**

Mr. Testa reported that he has completed preparation of the Authority's Secondary Market Disclosure Report. As reported at last month's meeting, this report updates the economic and demographic information of the City of Bridgeton and the Township of Upper Deerfield that was included in the Authority's last official statement issued in connection with the Series 2006A and 2006B Bond Issues. The report will be forwarded to the Trustee, and will be sent by them electronically, together with the previously submitted year 2012 Audit report, to the national repository that collects updated information on all bond issuers. This is due by June 30.

Mr. Testa stated that he is preparing the updated calculation of the Authority's maximum allowable Connection Fee as of December 31, 2012 in accordance with the Statues. (N.J.S.A. 40:14B-22). The calculation should be completed by June 21, 2013.

Mr. Testa also reported that he is working with management, the trustee and Bond Counsel regarding the Bond Reserve Fund requirement and related investments contained therein.

#### **General Counsel**

Mr. O'Donnell stated that he reviewed the bids that were submitted and part of today's agenda and found all bids submitted met all legal requirements.

Mr. O'Donnell noted that he spoke on several dates with the Director regarding the Crack/Joint repair and resurfacing problem. He advised that the bond company should be put on notice of the problem, as well as the contractor. The director has since notified the Bond Company. Mr. O'Donnell completed the Notice of Claim form supplied by the Bond Company and along with other documents requested by them were sent to the Bond Company.

The draft of the complaint against the delinquent hauler, KB Septic was provided to staff for their review and will be filed shortly.

Mr. O'Donnell stated he was available for any questions or concerns by staff and commissioners.

#### **Committees**

There were no committee meetings or reports issued for the past month.
