RESOLUTION TO APPROVE SHARED SERVICES AGREEMENT FOR EFFICIENCY AUDIT

WHEREAS, the "Uniform Shared Services and Consolidation Act" N.J.S.A. 40A:65-1, et seq. authorizes local units to enter into a shared service agreement with any other local unit to provide or receive any service that each local unit participating in the shared service agreement could provide or receive on its own; and

WHEREAS, in an attempt to identify cost-saving measures, the County of Cumberland, the Cumberland County Board of Social Services, the Cumberland County Improvement Authority and the Office of Workforce Development have discussed with the Cumberland County Utilities Authority specific areas where services may be shared to improve efficiency within the County of Cumberland; and

WHEREAS, the Cumberland County Utilities Authority recognizes the importance and need for efficiency and reducing cost; and

WHEREAS, as a part of ongoing discussions and negotiations, an Agreement has been drafted between the County of Cumberland (County), the Cumberland County Board of Social Services (Social Services), the Office of Workforce Development (Workforce Development), the Cumberland County Improvement Authority (CCIA) and the Cumberland County Utilities Authority (CCUA) (together referred to as the "Local Units") for the CCIA to provide services to the Local Units, as outlined in said Agreement; and

WHEREAS, CCIA shall be responsible for hiring or appointing an efficiency consultant (the Consultant), who shall serve the CCIA as well as the County, the CCUA, Social Services, and Workforce Development for a period of one (1) year at a cost to the Cumberland County Utilities Authority, the amount of \$5,000; and

WHEREAS, the Director and Operations Committee recommend the execution of this Agreement.

NOW, THEREFORE, BE IT RESOLVED by the Commissioners of the Cumberland County Utilities Authority as follows:

- 1. That the Director be authorized to enter into a Shared Service Agreement with the Cumberland County Improvement Authority, the County of Cumberland, the Cumberland County Board of Social Services and the Office of Workforce Development in relation to hiring an Consultant.
- 2. That the Authority's obligation in this Shared Service Agreement shall not exceed \$5000.00.

REGULAR MEETING CUMBERLAND COUNTY UTILITIES AUTHORITY March 21, 2013

The Cumberland County Utilities Authority (CCUA) held its Regular Monthly Meeting on Thursday, March 21, 2013 in the Meeting Room of the Operations Building, 333 Water Street, Bridgeton, New Jersey.

Representing the CCUA: Albert Jones, Chairman Keith Wasserman, Vice Chairman Edward Bethea, Commissioner Sam Boutros, Commissioner Angelia Edwards, Commissioner Harvey Friedman, Commissioner Donald Olbrich, Commissioner Steve Testa. Auditor Robert O'Donnell, General Counsel James Quinn, Treasurer C. Kenneth Hill, Secretary G. Steven Errickson, Director A. Michael Fernandez, Deputy Director Sandy Acevedo, Business Administrator Patti McAllister, Assistant Secretary – Treasurer

Chairman Jones called the meeting to order, announced that adequate notice of this meeting has been given in accordance with Chapter 231, P.L. (THE OPEN PUBLIC MEETING ACT) and led in the flag salute.

General Counsel O'Donnell gave an Oath of Office to Edward Bethea, appointed as Commissioner of the Cumberland County Utilities Authority.

Secretary Hill called the roll and a quorum was present.

Chairman Jones called for a motion to approve the minutes of the Regular Monthly Meeting of February 21, 2013. Motion was made by Vice Chairman Wasserman, seconded by Commissioner Friedman and was carried unanimously at roll call, with Commissioner Bethea abstaining and Commissioner Olbrich not yet at the meeting.

REPORTS

Director

Director Errickson welcomed the newest Commissioner Edward Bethea. He stated that they met last week to discuss plant operations and general business of the Authority. Mr. Bethea was given the Commissioners Handbook on disk and also a plant wide tour by Deputy Director Fernandez, answering any questions Mr. Bethea had.

Director Errickson submitted the February 2013 Discharge Monitoring Report (DMR) for inclusion in the minutes of this meeting. He stated that all parameters were met.

Director Errickson reported on the activities for the month which included:

Bids for "Electrical Consumption Optimizing Equipment" which is currently being advertised. Research indicates real savings in energy consumption with such a device.

Cleaning out the Digester Tanks and performing a cost analyst regarding the cleaning, using inhouse labor, versus private contractor versus, using a project contractor.

He also informed the board of his attendance at the pre-construction meeting in February for the Treatment Plant Upgrades Project #S340550-06. The work is expected to start soon. He stated that he is still waiting on the contractor's schedule.

Director Errickson further reported that he held two employee meetings this month, first with administrative staff and second with staff and all plant personnel. Feedback was good and he plans to hold meetings monthly or as needed. He also stated that he is in process of reviewing the personnel handbook, audit review and budget reports.

The Director reported that he attended the A.E.A. Conference in Atlantic City on March 12 and 13, 2013. He also attended a seminar with statewide Authority Directors and shared information and experiences beneficial to all.

As to sludge disposal, he reported that field work is off to a slow start at Cumberland Nurseries, resulting in the need to haul liquid sludge to the GCUA incinerator.

Director Errickson further stated that although the Authority met all permit requirements in February, by the end of the month very high oil and grease loads were detected from industrial sources creating operational problems which will likely result in effluent violations in March. The source has been tentatively identified. It seems, Buona Vita is again discharging high levels of oil and grease, apparently during cleanup operations on weekends. We had previously identified this as a problem in December and notified management about it. Beginning the end of February and continuing until March, we again experienced similar problems with them. We have increased monitoring frequencies and will be taking enforcement action.

He reported that a plant inspection by the DEP was performed on March 12, 2013. No significant deficiencies were noted; a few reports were found missing from the DEP database, all relating to parameters that are only required to be reported every five years. These are being submitted as "no discharge" reports.

Director stated that he and Mike Fernandez met with Upper Deerfield Township to discuss amendments to their sewer use ordinance as a result of changes we made to our billing method. They will be provided with some calculations relating to their industrial dischargers to assist any changes they may want to make.

The NJDEP lab audit has been rescheduled from March 6 to March 27, 2013.

Director Errickson was pleased to announce that the Authority and Employees received another Governors Safety Award for "no lost time accidents". This is the 9th consecutive award presented to the Cumberland County Utilities Authority, for twelve years of "no lost time".

Briefly reviewing the resolutions on the agenda, the Director stated that "Resolution A" allows CCUA to enter into Shared Services Agreement to conduct an Efficiency Audit with Cumberland County, CCIA, Cumberland County Board of Social Services and Cumberland County Office of Workforce Development.

"Resolution B" allows notice of solicitation for professional consulting engineering service. "Resolution C" is self explanatory (Nancy Sungenis)

The Director stated that the 2013 Plant Upgrades Project presents a possible need to prepare for outside bids for the cleaning and removal of contents from two Digesters, if necessary. The original plan was to perform this portion of the project in-house. Unfortunately, we have run into different site condition and unforeseen circumstances. The tanks are plugged at a much higher level than first estimated, causing us to rethink our strategy as to the most cost effective way to perform this work. We are looking at three options: 1) in-house as planned, 2) a change order with DEP or 3) an independent contractor. "Resolution D" would allow us to move forward with option 3, if needed, to bid to an outside contractor (RFP), giving us the ability to move quickly and keep pace with the phasing of the contract work. Again this will only be performed as a cost comparison to other options, and only acted upon with Board approval.

In conclusion, Director Errickson thanked Deputy Director Mike Fernandez, Patti and Sandy for their assistance with his report.

Engineer

There was no Engineer report, however a letter of Resignation from Adams, Rehmann & Heggan was read into the record by Chairman Jones.

Auditor

Mr. Testa reported that he finalized fieldwork on the 2012 Audit, today. He further stated that they are also working on completing the draft of their portion of the 2012 Audit Report. Management will then be provided with the draft information to enable the Authority to prepare its section, namely, the Management's Discussion and Analysis. We will also review the draft with Management. Once the entire report is complete, the draft will be provided to the Finance and Budget Committee for their review. Next a committee meeting should be held to review the draft report. Once approved, a copy of the draft will be sent to all of the Commissioners for their approval. Receipt of the final report should be acknowledged and certified by the Commissioners at the April meeting.

General Counsel

Mr. O'Donnell stated that he reviewed the agreement, resolution of the Cumberland County Improvement Authority and proposed Resolution concerning the Shared Services Agreement. He further stated he provided a memorandum to the Director, prior to the Committee meeting, to discuss the issue.

In conclusion, Mr. O'Donnell noted that he was available for any question and concerns by the Director, staff and Commissioners.

Committees

The Operations/Insurance Committee met on Tuesday, March 19, 2013. The purpose of the meeting was to discuss a shared services agreement with various County agencies. After a very involved discussion, it was agreed that we should proceed with the agreement and present a resolution at the next

regular board meeting on Thursday, March 21, 2013. Minutes of the meeting were included in the Commissioners packages.

Chairman Jones asked if there were any questions and there were none.

Chairman Jones also read a proclamation from the Board of Chosen Freeholders, honoring Nancy Sungenis.
