RESOLUTION TO AUTHORIZE FORMAL REQUEST ON BEHALF OF CUMBERLAND COUNTY BOARD OF HEALTH TO THE NEW JERSEY DEPARTMENT OF ENVIRONMENTAL PROTECTION, DIVISION OF FISH AND WILDLIFE

WHEREAS, the Cumberland County Utilities Authority was created in 1971 by resolution of the Cumberland County Board of Chosen Freeholders "for the purpose of protecting...rivers, streams, waterways, or estuaries from pollution in the County", and;

WHEREAS, the Cohansey River, being one of the two major rivers in the County and the location of the Authority's water pollution control facility, is a significant recreational resource that has been found to be impaired for contact recreation, and

WHEREAS, the Cumberland County Department of Health, Environmental Division has performed water sampling at various locations in the Cohansey River Watershed and found high coliform levels that do not correlate with human activity, and;

WHEREAS, further testing is necessary to determine the species of origin for these coliform bacteria in order to protect public health and permit contact recreation; and

WHEREAS, the Cumberland County Department of Health does not have adequate resources to conduct the necessary analysis and requires assistance from the New Jersey Department of Environmental Protection, Division of Fish and Wildlife to determine the species of origin.

NOW, THEREFORE, BE IT RESOLVED, by the Commissioners of the Cumberland County Utilities Authority to authorize the support of a formal request by the Cumberland County Board of Health to the New Jersey Department of Environmental Protection, Division of Fish and Wildlife to determine the species of origin for the E.coli contamination found by the Cumberland County Department of Health, Environmental Division in the Cohansey River Watershed, specifically in lakes and streams in and around Mary Elmer Lake, Silver Lake and Sunset Lake in Upper Deerfield.

# REGULAR MEETING CUMBERLAND COUNTY UTILITIES AUTHORITY June 19, 2014

The Cumberland County Utilities Authority (CCUA) held its Regular Monthly Meeting on Thursday, June 19, 2014 in the Meeting Room of the Operations Building, 333 Water Street, Bridgeton, New Jersey.

Chairman Jones called the meeting to order, announced that adequate notice of this meeting has been given in accordance with Chapter 231, P.L. (THE OPEN PUBLIC MEETING ACT) and led in the flag salute.

Secretary Hill called the roll and a quorum was present. Commissioners Bethea and Edwards were absent, with Commissioner Edwards recorded as an excused absence.

Chairman Jones called for a motion to approve the minutes of the Regular Monthly Meeting of May 15, 2014. Motion was made by Commissioner Olbrich, seconded by Commissioner Friedman and was carried at roll call.

Chairman Jones called for reports.

#### **REPORTS**

#### Director

Director Errickson submitted the May 2014 Discharge Monitoring Report (DMR) for inclusion in the minutes of this meeting.

The Director reported that he recently met with Jerry Velazquez and James Watson from the Cumberland County Improvement Authority to discuss shared services and joint ventures.

He, along with Deputy Director Fernandez, also attended a Wastewater Feasibility Study held at the Bayshore Center in Bivalve.

The Director further reported that he attended a Bankers Roundtable Conference at Cumberland County College sponsored by the Cumberland County Freeholders. The major topic discussed was to encourage leadership and investment in Cumberland County and to develop a team working together to improve the economy.

He also informed the board that he met with plant engineer, Jerry Harris and Ken Drews, regarding funding for future Capital Projects. And, he attended the Cumberland County Insurance Commission regular monthly meeting.

The Director stated that he and staff are working on the scope of the work for the North Clarifier.

The Director informed the Board that he has reviewed applications and is currently in the process of conducting interviews for the Business Administrator position.

He also noted that some members of the Board have been in to submit their Financial Ethics Statement online and reminded those that had not, to do so.

The Director continued his report on the activities of Authority operations, stating that we are hauling sludge to Gloucester County Utilities Authority at the present and expect to get back to Cumberland Nurseries in the beginning of July.

He reported that there was a second violation for Ammonia during May. The Ammonia limit is 35, and the reported value was 35.7. While these are still below the mandatory penalty threshold, the recurrence is troubling. At this point they do not appear linked to any industrial discharge. We have been looking into the aeration system as a possible contributing factor and have recently seen some encouraging results. With the new aeration system being more efficient, it is highly possible that our old operations procedures may not produce the best results.

Director Errickson noted that the permit application for NJ Ethanol in the Bridgeton Industrial Park continues to be under review. Additional information was requested from them, and some received, but it was a little vague on specifics. He further noted that all of our industrial discharges were in compliance with their permits this month.

There was a issue at Cumberland Regional High School due to a leak in their discharge pipe to the Upper Deerfield force main. The Authority assisted them with locating shut off valves and providing an alternative discharge point for trucked waste that was closer than Bridgeton. The pipes have since been repaired and are back in service.

Deputy Director Fernandez attended an emergency planning meeting sponsored by DEP and AEA earlier this month. DEP is emphasizing emergency response plans during plant inspections this year, and is proposing a standardized format for them. We are reviewing our plans for any needed future updates.

In closing, the Director thanked the Deputy Director Michael Fernandez, Business Administrator Sandy Acevedo and Administrative Assistant Patti McAllister for their help with his reports this month.

#### **Engineer**

Mr. Harris reported that he participated in a meeting on June 4, 2014 with the US Department of Agriculture and Director Errickson to explore funding opportunities for Authority Capital Projects.

And as requested, he has continued the review of Wastewater Discharge Permit Application submitted by New Jersey Ethanol, LLC.

#### **Auditor**

Mr. Testa reported that he is in the process of preparing the Authority's Secondary Market Disclosure Report. This report updates the economic and demographic information of the City of Bridgeton and the Township of Upper Deerfield that was included in the Authority's last official statement issued in connection with the Series 2006A and 2006B Bond Issues. Once completed, the report will be forwarded to the Trustee, and will be sent by them electronically, together with the previously submitted year 2013 Audit report, to the national repository that collects updated information on all bond issuers. This is due by June 30, 2014.

In the next few weeks he will be preparing the updated calculation of the Authority's maximum allowable Connection Fee as of December 31, 2013 in accordance with the Statutes (N.J.S.A. 40:14B-22).

#### **General Counsel**

Mr. O'Donnell stated that he had forwarded correspondence to Bridgeton and Upper Deerfield Twp. regarding their contracts with the Authority and the need to have them ratified by ordinance, not resolution.

Mr. O'Donnell reported that he is working with the Director on the connection issue with the City of Bridgeton and their new school. It is the Authority's position that the connection fee permit needs to be paid, while the City feels it is exempt.

Mr. O'Donnell stated that he attended a meeting with the Employee Relations Committee and Employee Representatives concerning negotiations and was available for any questions or concerns by staff and commissioners.

#### **Committees**

The Employee Relations Committee met with Employee Representatives on May 20 and 27, as well as June 3, 2014. The purpose of these meetings was to begin and continue discussions concerning employee related negotiations for the upcoming contract period.
