The Cumberland County Utilities Authority (CCUA) held its Regular Monthly Meeting on Thursday June 15, 2017, in the Meeting Room of the Operations Building, 333 Water Street, Bridgeton, New Jersey.

Vice-Chairman Wasserman called the meeting to order, announced that adequate notice of this meeting has been given in accordance with Chapter 231, P.L. (THE OPEN PUBLIC MEETING ACT) and led in the flag salute.

Secretary Hill called the roll and a quorum was present. Chairman Jones and Commissioner Young were recorded as excused absences. Commissioner Edwards was also absent.

Vice-Chairman Wasserman called for a motion to approve the minutes of the Regular Monthly Meeting minutes of May 18, 2017. Motion was made by Commissioner Friedman seconded by Commissioner Rajacich and carried unanimously at roll call.

#### **REPORTS**

#### Director

Director Errickson submitted the May 2017 Discharge Monitoring Report (DMR) for inclusion into the minutes of this meeting. The Director noted that the plant is operating well and we continue to meet our effluent discharge limits in the single digits.

Director Errickson reported meeting with Michael McCullen, President of CME our Engineering firm and Jerry Harris our Engineer this month. The purpose of the meeting was to discuss current projects and future maintenance and up-grades needed at our plant. The meeting went very well with some good ideas regarding the future needs of the Authority.

Director Errickson also reported meeting with Chuck Fralinger of Fralinger Engineering regarding construction drawings for this Authority. It appears that Fralinger Engineering has drawings we do not have regarding elevations within the plant and information on some of our buildings. They are willing to share them with us at no charge.

The Director also informed the Authority Board that he met with some of our Freeholders to give them a status report on the plant and explain some of the challenges we are facing. Discussed items included NJDEP and EPA's tighter regulations coming down the road and the need for qualified workers in the future.

Director Errickson noted that our latest meeting concerning the Solar Project was held in Trenton and went very well. Our Counsel will address this in his report.

The Director also reported that we held a Bid Opening for the flange drive. This has not been awarded as of this date.

Director Errickson reported several meetings were held with a few of our customers and that they went well, more about this will be discussed in Executive Session tonight.

The Director noted that we have built up some inventory of sludge this month and as a result have increased the amount of loads being hauled. We are currently disposing of four trailer loads per day at DELCORA with all hauling being done internally. This will be the normal rate of disposal for the next month. Sludge cake is being generated on a limited basis while we begin the process of optimizing the sludge screw press performance. Huber Technologies (the screw press manufacture) is scheduled to be onsite next month for machine optimization.

Director Errickson noted that Centerpoint is in the process of finishing the head structure sluice gate replacement project. The majority of gates have been replaced and are in service at this time. Also repainting operations have resumed at the north primary. Progress is being made and we expect the project to be completed on time.

Progress is continuing at the Seabrook pump station. Demolition work is completed and they have poured the pad for the prefab building. We are however experiencing problems with the pumps and we are currently in by-pass utilizing two Godwin pumps.

The Director reported that there are two resolutions tonight. Resolution "A" payment for our two construction projects. Resolution "B" authorizing full time employment to Fred Scioli as plant operator. Fred has completed his 90 probation period and is doing very well in his new position as operator trainee and we recommend his employment.

Director Errickson noted that there were no Committee meetings this past month.

In conclusion, the Director offered his thanks to Deputy Director Daniel Jefferson, Administrative Assistant Stephanie Mick, Business Administrator Dominic Buirch, and Authority Engineer Jerry Harris for their help with preparing his report.

#### Engineer

Upper Deerfield Pump Station, Lance Electric, Inc. of Tabernacle NJ was given a notice to Proceed on October 13, 2016. The contractor mobilized on site on April 10, 2017. Work is now proceeding with the first phase of the project which includes demolition of the existing generator building, providing a new pre-fab building and a new generator. Various major pieces of equipment have been delivered. The project is approximately 40 % complete. Completion date for contract is early November 2017.

Wastewater Treatment Plant Improvements, Centerpoint Associates, Blackwood NJ. Construction activities started the week of October 17, 2016. With the arrival of warmer weather, concrete repair/coating and metal painting activities have resumed at the North Primary Clarifier. Work continued at the Headworks facility with regard to the replacement/rehabilitation of gates and installation of new grating. The two new aeration blowers have been set in place in the Blower building. Contract is approximately 70% complete. Completion date for contract is late September 2017.

Mr. Harris reported that he has continued assisting staff in planning solids handling improvements for the Plant with an emphasis on screening improvements as a first phase.

Mr. Harris lastly reported that he was available to provide assistance to the Director and Deputy Director on engineering matters, and coordinated with Bond Counsel on NJEIT loan. He also noted that Asset Management Plan work is in the initial information gathering stage.

#### **Auditor**

Mr. Testa was absent from the meeting but submitted a report that was read into the record by Secretary Hill. Mr. Testa reported that they are in the process of preparing the Authority's Secondary Market Disclosure Report. This report updates the economic and demographic information of the City of Bridgeton, the Township of

Upper Deerfield and the County that was included in the Authority's last official statement issued in connection with the series 2006 Bond Issues. We are currently awaiting information from some of those entities in order to complete the report. Once completed, the report will be forwarded to the Trustee, and will be sent by them electronically, together with the 2016 Audit report, to the national repository that collects updated information on all bond issuers.

#### **General Counsel**

Mr. Grace reported that on June 8, 2017 Director Errickson, our professionals and himself had a follow-up meeting with Natalie Young of the NJDEP to discuss many issues related to the site conditions of the property we are desirous of using for our solar farm. This meeting came on the heels of our receipt of the Letter of Interpretation supplied to us which outlined, among other things, the possibility of the need for a Three Hundred (300) foot buffer for the delineation of the Coastal wetlands that exist on the property. In addition, we were advised that there is a need for a Coastal Area Facility Review Act-Individual Permit (CAFRA-IP) on the property, furthermore, there was an extensive discussion regarding the existence of Freshwater Wetlands, eagle foraging and minimizing disturbance of the natural state of the property.

During the course of the lengthy discussion in which negotiations ensued we were able, due to the thorough research and diligent work of our team, to convince the NJDEP that a Fifty (50) foot buffer would be appropriate under the circumstances. It is very important to note that if the requirement for a Three Hundred (300) foot buffer would have been maintained, the project would have failed as there is no remaining area to place solar panels. Thus, the CCUA made an extremely positive step in the direction of making the solar project a reality thereby providing a significant public benefit.

Now that this step has been completed we are required to turn our attention to the need for completion and submission of the CAFRA-IP. It is important to note that the fees to the NJDEP, for a permit of this nature given the acreage of the proposed site, will be significant. We will also need to make a provision of the completion of the appropriate studies for purposes of supplying the data necessary to obtain the CAFRA-IP. Also, the statutory timelines will make this process take approximately six (6) to nine (9) months. Therefore, if we move forward expeditiously, we have the chance to have this work completed, our application submitted and approved by mid-winter which could allow us to have the chance to cause construction to occur in spring of 2018. With the potential savings associated with our ability to have inexpensive, clean renewal electric power in the near future our Authority can serve as an example to others of how we can address a significant public concern, help preserve the environment and place less reliance on outside forces. While there is still much work to be done, congratulations should go out to Director Errickson and everyone who is a part of the CCUA for their dedication to a worthy cause.

Mr. Grace stated he was available for any questions or concerns by the Director, staff and Commissioners.

BE IT RESOLVED BY THE CUMBERLAND COUNTY UTILITIES AUTHORITY (the "Authority"), as follows:

Section 1. The costs and expenses which are set forth in the certificate entitled "Requisition and Certification as to Payment of Costs and Expenses From the CCUA Series 2016 NJEIT Construction Fund" which is attached hereto as Exhibit A and which, by this reference, is made a part hereof as if set forth in full herein, are hereby authorized to be paid on November 21, 2016 from monies which are on deposit in the CCUA Series 2010-2016 NJEIT Construction Fund, which has been established and created in accordance with the provisions of a Resolution of the Authority, duly adopted January 21, 2016, entitled "Supplemental Resolution Authorizing the Issuance of Not to Exceed \$2,200,000 Aggregate Principal Amount of Sewer System Revenue Bonds, Series 2016 of the CCUA".

Section 2. TD BANK, NA, Cherry Hill, New Jersey, in its capacity as Trustee for the holders of the CCUA Series 2010-2016 NJEIT Construction Fund, is hereby authorized to withdraw such monies from the Fund, and to make payment of same, in accordance with the terms hereof and the terms of the attached requisition.
