CUMBERLAND COUNTY UTILITIES AUTHORITY February 15, 2018

The Cumberland County Utilities Authority (CCUA) held its Regular Monthly Meeting on Thursday February 15, 2018, in the Meeting Room of the Operations Building, 333 Water Street, Bridgeton, New Jersey.

Chairman Jones called the meeting to order, announced that adequate notice of this meeting has been given in accordance with Chapter 231, P.L. (THE OPEN PUBLIC MEETING ACT) and led in the flag salute.

Secretary Hill called the roll and a quorum was present. Commissioners Angelia Edwards and Jerry Young were recorded as excused absences.

Chairman Jones called for a motion to approve the minutes of the Regular Monthly Meeting of January 18, 2018. Motion was made by Commissioner Rajacich, seconded by Vice-Chairman Wasserman and carried unanimously at roll call.

Vice Chairman Wasserman made a motion requesting that General Counsel be appointed temporary Chairman for the purpose of electing a Chairman of the Authority for 2018 seconded by Commissioner VanSant and carried unanimously at roll call. Vice-Chairman Wasserman nominated Albert Jones, seconded by Commissioner VanSant and carried unanimously at roll call.

RESOLUTION (2902) APPOINTING CHAIRMAN OF THE CUMBERLAND COUNTY UTILIES AUTHORITY offered by Vice-Chairman Wasserman, seconded by Commissioner VanSant and carried unanimously at roll call.

Chairman Jones assumed the Chairman's seat and called for nominations for the office of Vice-Chairman of the Authority for the year 2018. Commissioner VanSant nominated Keith Wasserman seconded by Commissioner Rajacich and carried unanimously at roll call.

RESOLUTION (2903) APPOINTING VICE-CHAIRMAN OF THE CUMBERLAND COUNTY UTILITIES AUTHORITY offered by Commissioner VanSant, seconded by Commissioner Rajacich and carried unanimously at roll call.

Chairman Jones announced that Committee assignments would remain the same for the year 2018.

REPORTS

Director

Director Errickson submitted the January 2018 Discharge Monitoring Report (DMR) for inclusion into the minutes of this meeting. The Director noted that the plant is operating well, and we have not experienced the same cold weather as last month and the plant effluent has gotten progressively better. The plant bioactivity is compromised at low temperatures and that can present a challenge for plant operations staff and can sometimes affect the quality of the effluent. The more seasonable temperatures have allowed us to generate an effluent well within plant permit conditions.

Director Errickson reported that he and Dan Jefferson attended a meeting with Bob Brewer and Sharon Mollick from the County Planning Board. They requested our help in updating the County Waste Management Plan.

The Director informed this board that he attended a luncheon with the Bridgeton Area Chamber of Commerce this month. Freeholder Director Derella was the main speaker that day and he spoke about the condition of the County and some of the great things taking place such as the new Vocational School, and the many projects sponsored by the CCIA that are promoting some economic growth. Mr. Derella also spoke about the CCUA and the fact that we have capacity to accept new industry that would like to come to this area, and what a fine organization the CCUA is and helping in promoting the County.

The Director reported on Bondex Bond Company and that the action taken by them has been very slow. In your packets today is a copy of an e-mail letter demanding a mandatory meeting here at the CCUA with all stake holders in order to get things moving. We finally did meet last Thursday February 8, 2018 to discuss project take over agreement and establish time frames for completion. Because of possible ligation we will need to go into closed session to discuss all the details.

Director Errickson noted that he held a plant meeting with all employees to re-state and explain CCUA policy regarding vacations, sick time and personal time. No one had any questions or expressed any concerns.

The Director reported that Mr. Ryan Seibert Environmental person from Calmar Associates has almost completed his work on underground storage tanks removal that was actually done 25 years ago. We did have to pay a \$3,500 close out fee to NJDEP that was much better than a large fine as was threatened. Sometimes there is a cost in doing business in New Jersey.

The Director noted that we have a problem with foam overflow from primary digester into our boiler. We run our boilers on natural gas and also on methane gas produced by our digester. Mainly we run on methane because it's free. If we do not have enough methane, natural gas comes on as our back up. We believe foam is forming in our digester and getting into our methane pipe and flooding the line shutting off the boiler. We have mitigated the issue but are searching for the cause.

Director Errickson also noted that Mr. Joseph Bonaccorso from CME who is a Project Manager and expert in "Sewer Plant Operations" was on site Thursday February 8, 2018 to look over our facility and its operation. Joe had a few recommendations we are going to utilize.

Director Errickson reported this month has seen a slight increase in sludge storage tank levels. As a result we have increased the amount of loads being hauled to DELCORA and we are also sending 100,000 gallons to Ash Lane, C&H's land application site. We anticipate returning to normal tank levels in the coming weeks.

The Director noted that work at the plant Head Structure and the Primary clarifier have come to a close. The punch list at both locations is being completed and operations has begun planning when to place the north primary in service.

The Director noted that work at the Seabrook pump station has been paused while the issues regarding Lance Electric are resolved. We have called in the bond and are looking forward to work resuming with a more competent contractor. Several meetings with the bond company, Bondex, have been productive and we anticipate work moving forward soon.

Director Errickson reported Analytical Laboratory Services (ALS), the outside laboratory contractor is in its second month of service and all is going well. We continue to look for better ways to improve on the efficiency of sample collection and analysis.

We have ten resolutions tonight to vote on.

Resolution "A" is to set meeting dates for the CCUA this year.

Resolution "B" is to appoint C. Kenneth Hill as Secretary to the CCUA.

Resolution "C" is to extend contract with Archer & Greiner as special Counsel for the Solar Project.

Resolution "D" authorizing advertisement for bids for repair of South Primary Clarifier and South Secondary Primary, New Drive unit in each one.

Resolution "E" authorizing advertisement for bids for repair of "South Secondary Primary" metal work only.

Resolution "F" authorizing advertisement for bids for roofing for the Administration and Dewatering buildings.

Resolution "G" authorizing advertisement for bids for Asphalt repairs.

Resolution "H" authorizing advertisement for bids for miscellaneous construction.

Resolution "I" authorizing advertisement for bids for cleaning of Primary Digester.

Resolution "J" agreement with Bondex Insurance Company to move forward with the Upper Deerfield Pump Station Project.

In conclusion, the Director offered his thanks to Deputy Director Daniel Jefferson, Administrative Assistant Stephanie Mick, Business Administrator Dominic Birch and. Authority Engineer Jerry Harris and the entire staff for their help with preparing his report.

Engineer

Upper Deerfield Pump Station- Lance Electric, Inc. of Tabernacle NJ. The contractor was terminated from the contract. Discussions in progress with bonding company regarding completion of the work. CME attended meeting with bonding company on February 8, 2018. Project remains at approximately 70% complete. Completion date for contract was early November 2017.

Wastewater Treatment Plant Improvements- Centerpoint Associates, Blackwood NJ, contract is 95% complete. Contractor has been given a punch list of outstanding items which have not been completed. In addition, various submittals are required from the contractor before the project closeout procedure can be completed.

Mr. Harris also reported preparation of the asset inventory, initial condition assessment and valuation of facilities is complete. A draft plan has been completed and submitted to CCUA Staff for review.

Mr. Harris lastly reported that he was available to provide assistance to the Director and Deputy Director on engineering matters, and coordinated with Bond Counsel on NJEIT loan.

Auditor

Mr. Testa reported that we have been working on the 2017 Audit. To date, we performed the majority of the fieldwork and have been receiving certain work papers and supporting documents from the Authority, and have been auditing that information remotely as well. We are awaiting certain information pertaining to the construction projects and NJEIT Funding. In addition, we have to wait for the GASB 68 Pension Reports from the state of New Jersey to be able to complete the Audit. We will keep the Authority informed as to the progress of the Audit and the financial statements.

General Counsel

Mr. Grace reported that we have asked for an extension to award the contract and have prepared the RFP in the Proposed Solar Project matter. As a result, assuming that the approval is given, we hope to have the RFP out within fifteen (15) days.

A meeting was held last week as to the Lance Electric matter. We have a tentative agreement however, after review of some of the numbers with the Director and Finance, it was apparent that there were requests for payments that may have been premature. As a result, we are going to go back and adjust the numbers

appropriately, so as to reflect the allocation of funds and hope to have this matter moving forward to completion expeditiously. I will keep this Board advised as we move forward in this matter.

As to the Center Point matter, there is no new information to report at this time. We will update as new information becomes available.

Mr. Grace stated he was available for any questions or concerns by the Director, staff and Commissioners.
