CUMBERLAND COUNTY UTILITIES AUTHORITY March 18, 2021

The Cumberland County Utilities Authority (CCUA) held its Regular Monthly Meeting on Thursday March 18, 2021 in the Meeting Room of the Operations Building 333 Water Street, Bridgeton, New Jersey. The meeting was also attended by several persons via Zoom.

Representing the CCUA: Albert Jones, Chairperson Rick Dawson, Vice Chairperson William Andre, Commissioner Angelia Edwards, Commissioner Zarko Rajacich, Commissioner Kenny Smith-Bey, Commissioner John Fuqua, Secretary G. Steven Errickson, Executive Director Todd Edwards, Treasurer Gregg L. Zeff, General Counsel Steve Testa, Auditor Glenn Miller, Engineer Stephanie Mick, Assistant Secretary/Treasurer Bob Carlson, Resident Engineer Dominic Buirch, Business Administrator Daniel Jefferson, Executive Deputy Director

Vice Chairperson Dawson called the meeting to order, announced that the adequate notice of this meeting has been given in accordance with Chapter 231,P.L (THE OPEN PUBLIC MEETING ACT) the flag salute was performed.

Vice Chairperson Dawson called R. Todd Edwards forward to be sworn in as a new Commissioner, General Counsel Zeff administered the oath of office.

Secretary Fuqua called the roll, and quorum was present. Chairperson Jones and Commissioner Rajacich and Executive Director Errickson were not present at the start of the meeting due to issues with Zoom technology they were able to join at 4:40pm.

Vice Chairperson Dawson called for a motion to approve the minutes of the Regular Monthly Meeting of February 18, 2021. Motion was made by Commissioner Edwards and seconded by Commissioner Andre and carried unanimously at roll call.

Vice Chairperson Dawson welcomed new Commissioner Edwards.

Vice Chairperson Dawson called for Directors' report.

REPORTS

Director

Director Errickson submitted the February 2021 Discharge Monitoring Report (DMR) for inclusion into the minutes of this meeting. The activities for the month.

Activities

Solar: Solar farm is up and running and is performing well. Nextera and Atlantic City Electric are working together to install the up dated equipment on site.

Upper Deerfield Our Solicitor will report in more detail but anticipate we will meet with Upper Deerfield very soon.

Labor Negotiation-Personnel Committee met with Labor Counsel Friday, March 05, 2021 to discuss moving forward. Commissioner Rajacich will report on that. Marmero Law will be voted on tonight as the new labor counsel to represent CCUA.

Plant employees have signed union cards wishing to join the CWA Union. We are following instruction from Labor Counsel about this matter and expects talks to begin soon. We will talk more in closed session.

Covid-19 There are no current COVID-19 cases in the Authority at this time. One member's wife is very sick and is in the hospital, and we ask you to keep her in your prayers. Also again Thank you to all the other Authorities who were on standby and ready to help the CCUA if needed. The Authority continues to follow the recommended guidelines provided by the C.D.C

The UK variant has been contracted by one known person in the county as of this week. The person works outside the County and could have contracted the Variant there. The number of Covid cases has been going down the last couple of weeks, but in the last few days the County has seen a sharp increase with 73 new cases in two days. This shows that Covid virus battle is not over, and we must be safe and follow C.D.C guidelines.

In the last couple of weeks there has been two resignations One Maintenance person and one plant operations.

Sludge disposal - The Director also noted the Authority is currently hauling two loads a day to DELCORA with C&H providing assistance when needed. The sludge storage tank level is increasing at this time. The Authority will be hauling to Ash Lane this month to help decrease the additional volume.

Plant discharge. The plant is operating well, and we are meeting our effluent discharge limits, in some cases we are meeting those limits in the single digits.

The Director noted the following as to Operations and Maintenance:

Maintenance personnel have installed new flow meters at both the north and south gravity belt thickeners.

Garrison Enterprises has installed new feed valves to both the north and south gravity thickener tank.

GMH, Inc. is making progress with the on-going thickener tank, rehabilitation project. Currently the catwalk and rake arm work is being completed at the south tank.

This month the Authority has ordered the equipment for the bar screen and grit system replacement which is part of the larger headworks up-grade project.

Maintenance has resolved the drain issues at the biofilter. The biofilter will be placed back in service when this work is completed.

Blowers #1 & #4 are having vibration issues at the same time. Excelsior Blower Systems, Inc has been contracted to diagnose the source of the vibration and rectify the problem.

Miscellaneous

The Authority has received two employee resignations this month one from Chris Newsome in operations and another from Carlos Pacheco in maintenance. Both resignations have been accepted by the Authority.

The new sludge tanker bid has been awarded and the tanker has been ordered this month.

The Authority has had the bid open for the Headworks Project this month.

Committee Reports: Zarko Rajacich will report on Employee Relations Committee.

Director Errickson reported there are seven (7) resolutions on the agenda for tonight; Resolution 3152 Contract for Head Works analysis, Resolution 3153 RFQ for IT consulting service, Resolution 3154 Using Co-op to purchase Four (4) golf carts, Resolution 3155 Authorizing advertisement to bid Headworks Project, Resolution 3156 Resolution to continue to use Truist Bank and TD Bank, Resolution 3157 Resolution approving and adopting revisions to cash management plan, Resolution 3158 Resolution appointing Donald Olbrich as treasurer.

Mr. Errickson stated there is no Closed session planned tonight.

Headworks Grit and Screen Replacement: The project equipment has been placed on order by the Authority from Hydro-Dyne Engineering Inc: Applied Industrial Technologies is the Co-op contractor: Applied will use authorized subcontractors ;Applied will use authorized subcontractors for the installation of equipment. Pennoni construction documents are on hold and will be canceled pending award of the installation contract.

NJDEP TWA application: Submitted November 10,2020; NJDEP Permit approved and received.

Pennoni attended pre-construction site visit with Applied on February 10th

Equipment delivery in 20 weeks our; Anticipated start of construction September 2021

Replacement of laboratory hood: Pennoni is preparing plans for designs and construction and replacing the existing hoods.

Regarding Glass Street Pump Station and Force Main Upgrade: Pennoni survey to start March 2021. Pennoni coordinating design for the pump station upgrades with the Authority. Anticipated project Permit/I-Bank funding 2021; Construction anticipated 2022. Estimated Project cost \$3.3 Mil.

EQ Tank Structure: Pennoni to preparing technical specifications for structure repair and rehabilitation.

Primary Digester: Pennoni to perform requested structural and wielding inspections as needed.

Request to receive backwash water from Upper Deerfield Township (UDT): Pennoni assisting the Authority, as needed.

Upper Deerfield Sewer Pipe Rehab: We anticipate work in 2021

That any three (3) of the following Chairperson, Secretary, Treasurer or Vice-Chairman are authorized on behalf of the Cumberland County Utilities Authority to sign checks, savings withdrawals, and other instruments and orders for the payment of money or for the withdrawal or delivery of funds or other property at any time held by the Bank for the account of the Cumberland County Utilities Authority and to receive any thereof, and to issue instructions for the conduct of any account of the Cumberland County Utilities Authority with the Bank (b) to accept drafts, and other instruments payable at the Bank, and to Waive Demand, Protest and Notice of Protest or dishonor of any instrument made, drawn or endorsed by the Cumberland County Utilities Authority (c) to endorse, negotiate and receive, or authorize the payment of, the proceeds of, any negotiable or other instruments or orders for the payment of money payable to or belonging to the Cumberland County Utilities Authority.
- 4. That the Bank may honor all such checks and other instruments for the payment or delivery of money or property when signed as authorized above.
- 5. That the Bank as a designated depository, be, and thereby is authorized and directed to honor any oral telephonic order to transfer monies between the checking accounts and savings accounts and/or trustee accounts on behalf of the Cumberland County Utilities Authority by any person representing himself to be one of the above authorized signatures, the Executive Director, Deputy Director, or the person designated as the Authority Officer.
- 6. That the foregoing Resolution shall continue in full force and effect and the Bank may rely on it until a certified copy of a subsequent Resolution of the Board of Commissioners of the Cumberland County Utilities Authority modifying or rescinding any or all such resolutions shall have been actually received by the Bank.

Cumberland County Utilities Authority 2021 Cash Management Plan

I. STATEMENT OF PURPOSE

This Cash Management Plan (the "Plan") is prepared pursuant and subject to the provision of N.J.S.A. 40A: 5-14, et seq., as amended, in order to set forth the basis for the deposits ("Deposits") and investment ("Permitted Investments") of certain public funds of the Cumberland County Utilities Authority, pending the use of such funds for the intended purposes. The plan is intended to assure that all public funds identified herein are deposited in interest bearing Deposits or otherwise invested in Permitted Investments hereinafter referred to. The intent of the Plan is to provide that the decisions made regarding the Deposits and Permitted Investments will be done to ensure the safety, liquidity (regarding its availability for the intended purposes), and the maximum investment return within such limits. The Plan is intended to ensure that any Deposit or Permitted Investment matures within the time period that approximates the prospective need for the funds deposited or invested so that there is not a risk to the market value of such Deposits or Permitted Investments.

II. IDENTIFICATION OF FUNDS AND ACCOUNTS TO BE COVERED BY THE PLAN.

A. The Plan is intended to cover the deposit and/or investment of all funds and accounts of the Cumberland County Utilities Authority to include:

and such other accounts as the Authority may legally establish.

The custodian of the accounts shall be the Chief Financial Officer. All disbursements shall be made by checks signed by three persons ("Officers") authorized by Resolution of the Authority with the exception of Other Trust Funds/Trust Accounts, which require the signature of the Chief Financial Officer only, or any three other Officers.

The Executive Director of the Authority is hereby designated as the Chief Financial Officer for the purposes of this Plan.

III. DESIGNATION OF OFFICIALS OF THE CUMBERLAND COUNTY UTILITIES AUTHORITY AUTHORIZED TO MAKE DEPOSITS OR INVESTMENTS UNDER THE PLAN.

The Chief Financial Officer (the "Designated Official") is hereby authorized and directed to deposit and/or invest the funds referred to in the Plan. Prior to making any such Deposits or any Permitted Investments, such official of the Cumberland County Utilities Authority is directed to supply all depositories or any other parties with whom the Deposits or Permitted Investments are made a written copy of this Plan which shall be acknowledged in writing by such parties and a copy of such acknowledgment kept on file.

IV. DESIGNATION OF DEPOSITORIES.

The following banks and financial institutions are hereby designated as official depositories for

the Deposit of all public funds referred to in the Plan, including any certificates of deposit which are not otherwise invested in Permitted Investments as provided for in this Plan:

> BB&T TD Wealth Management

In addition, the Authority by Resolution may designate such other and/or additional financial institution as official depositories provided that any New Jersey bank must be covered by the New Jersey Governmental Unit Deposit Protection Act (GUDPA).

All such depositories shall acknowledge in writing receipt of this plan by sending a copy of such acknowledgment to the Designated Official (s) referred to in Section III above.

DESIGNATION OF BROKERAGE FIRMS AND DEALERS WITH WHOM THE V. DESIGNATED OFFICIALS MAY DEAL.

The following brokerage firms and/or dealers and other institutions are hereby designated as firms with whom the Designated Official(s) of the Cumberland County Utilities Authority referred to in this Plan may deal for purposes of buying and selling securities identified in this plan as Permitted Investments or otherwise providing for Deposit, to wit, any member of the New York Stock Exchange (NYSE), American Stock Exchange (ASE), National Association of Securities Dealers (NASD), provided all transactions are executed in the delivery vs. payment form between the brokerage firm or dealer and Cumberland County Utilities Authority's designated custodian. All such brokerage firms and/or dealers shall acknowledge in writing receipt of this Plan by sending a copy of such acknowledgement to the Designated Official(s) referred to in Section III above.

PERMISSIBLE INVESTMENTS. VI.

- Investments shall be limited by the express authority of the Local Fiscal Affairs Law, N.J.S.A. 40A:5-15.1 and except as otherwise specifically provided for herein, the Designated Official is hereby authorized to invest the public funds covered by this Plan to the extent not otherwise held in Deposits, in the following Permitted Investments:
 - Bonds or other obligations of the United States of America or obligations 1. guaranteed by the United States of America and/or bonds or other obligations of the State of New Jersey or any of its political subdivisions provided that said bond or obligation is a legally authorized investment.
 - Government money market mutual funds; 2.
 - Any obligation that a federal agency or a federal instrumentality has issued in 3. accordance with an act of Congress, which security has a maturity date not greater than 397 days from the date of purchase provided that such obligation bears a fixed rate of interest not dependent on any index or other external
 - 4. Bonds or other obligations of the Local Unit or bonds or other obligations of school districts of which the Local Unit is a part or within which the school district is located:
 - Bonds or other obligations, having maturity date not more than 397 days from 5. the date of purchase, approved by the Division of Investment of the Department of Treasury for investment by Local Units;
 - Local government investment pools; 6.
 - Deposits with the State of New Jersey Cash Management Fund established 7. pursuant to section 1 of P.L. 1977, c. 281 (C. 52:18A-90.4); or
 - Agreements for the repurchase of fully collateralized securities if 8.
 - the underlying securities are permitted investments pursuant to paragraphs (1) and (3) of this subsection;
 - the custody of collateral is transferred to a third party; b.
 - the maturity of the agreement is not more than 30 days;
 - the underlying securities are purchased through a public depository as d. defined in section 1 of P.L. 1970, c.236 (C.17:19-41); and
 - a master repurchase agreement providing for the custody and security e. of collateral is executed.

For purposes of the above language, the terms "government money market mutual fund" and "local government investment pool" shall have the following definitions:

Government Money Market Mutual Fund. An investment company or investment trust: Which is registered with the Securities and Exchange Commission under the (a)

- "Investment Company Act of 1940", 15 U.S.C. sec 80a-1 et seq., and operated in accordance with 17 C.F.R. sec 270.2a-7.
- (b) the portfolio of which is limited to U.S. Government securities that meet the definition of any eligible security pursuant to 17 C.F.R. sec. 270.2a-7 and repurchase agreements that are collateralized by such U.S. Government securities; and
- (c) Which is rated by a nationally recognized statistical rating organization.

Local Government Investment Pool. An investment pool:

- (a) which is managed in accordance with 17 C.F.R. sec 270.2a7;
- (b) which is rated in the highest category by a nationally recognized statistical rating organization;
- which is limited to U.S. Government securities that meet the definition of an eligible security pursuant to 17 C.F.R. sec 270.2a-7 and repurchase agreements that are collaterized by such U.S. Government securities;
- (d) which is in compliance with rules adopted pursuant to the "Administrative Procedure Act", P.L. 1968, c 410 (c52: 14B-1 et seq.) by the Local Finance Board of the Division of Local Government Services in the Department of Community Affairs, which rules shall provide for the safety, liquidity and yield of the investments;
- (e) which does not permit investments in instruments that: are subject to high price volatility with changing market conditions, cannot reasonably be expected at the time of interest rate adjustment, to have market value that approximates their par value; or utilized an index that does not support a stable net asset value; and
- (f) which purchases and redeems investments directly from the issuer, government money market mutual fund, or the State of New Jersey Cash Management Fund, or through the use of a national or State bank located within this State, or through a broker-dealer which, at the time of purchases or redemption, has been registered continuously for a period of at least two year pursuant to Section 9 of P.L. 1967 c.9 (C49:3-56) and has at least \$25 Million in capital stock (or equivalent capitalization if not a corporation), surplus reserves for contingencies and undivided profits or through a securities dealer who makes primary markets in U.S. Government securities and reports daily to the Federal Reserve Bank of New York its position in and borrowing on such U.S. Government Securities.

VII. SAFEKEEPING CUSTODY PAYMENT AND ACKNOWLEDGEMENT OF RECEIPT OF PLAN.

To the extent that any Deposit or Permitted Investment involves a document or security which is not physically held by the Cumberland County Utilities Authority, then such instrument or security shall be covered by a custodial agreement with an independent third party, which shall be a bank or financial institution in the State of New Jersey. Such institution shall provide for the designation of such investments in the name of the Cumberland County Utilities Authority to assure that there is not unauthorized use of the funds or the Permitted Investments of Deposits. Purchase of any Permitted Investments that involve Securities shall be executed by a "delivery versus payment" method to ensure that such Permitted Investments are either received by the Cumberland County Utilities Authority or by a third-party custodian prior to or upon the release of the Cumberland County Utilities Authority funds.

To assure that all parties with whom the Cumberland County Utilities Authority deals either by way of Deposits or Permitted Investments are aware of the authority and the limits sets forth in this Plan, all such parties shall be supplied with a copy of this Plan in writing and all such parties shall acknowledge the receipt of that Plan in writing, a copy of which shall be on file with the Designated Official(s).

VIII. REPORTING REQUIREMENTS

At least monthly at a public meeting of the Authority, the Designated Official(s) referred to in Section III hereof shall supply to the Commissioners of the Cumberland County Utilities Authority a report of any Deposits of Permitted Investments made pursuant to this Plan, which shall include, at a minimum, the following information:

- A. The name of any institution holding funds of the Cumberland County Utilities Authority as a Deposit or a Permitted Investment.
- B. The amount of securities or Deposits purchased or sold during the immediately preceding month.
- C. The class or type of securities purchased, or Deposits made.
- D. The book value of such Deposits or Permitted Investment.
- E. The earned income on such Deposits or Permitted Investments.
 - The fees incurred to undertake such Deposits or Permitted Investments.

- G. The market value of all Deposits or Permitted Investments as of the end of the immediately preceding month.
- H. All other information which may be deemed reasonable from time to time by the Commissioners of the Cumberland County Utilities Authority.

The report shall include all monthly trustee and other bank statements containing the required information.

IX. TERM OF PLAN

This Plan shall be in effect from January 2021 to December 2021. Attached to this Plan is resolution adopted by the Commissioners of the Cumberland County Utilities Authority approving this Plan for such a period of time. The Plan may be amended from time to time. To the extent that any amendment is adopted by the Commissioners of the Cumberland County Utilities Authority, the Designated Official is directed to supply copies of the amendments to all of the parties who otherwise have received the copy of the originally approved Plan, which amendment shall be acknowledged in writing in the same manner as the original Plan was so acknowledged.
